I Sri Sisir Kumar Das, S/O- Sri Banamali Das, A.E & Station Manager of Balarampur CCC of WBSEDCL do hereby lodge complaint against Sandip Karmakar, S/o. Lt. Baldyanath Das, resides at Goshala Road, Po. Rangadih, PS: Balarampur, Dist. Purulia to the effect that received an information that the aforesaid accused person is committing theft of Electricity in his electrical shop at Balarampur Bus Stand (Stall No:- 16) by way of tapping the incoming service cable to bypass the proper registration of units in the Energy Meter of WBSEDCL.

Acting upon such information today on 07.03.2022 from 12.40 PM to 1.10 PM I, along with Sri Manab Kr. Maji, J.E.(E) Gr-II , Sri Arindam Chatterjee, Sr. O.E, Balarampur CCC and technical persons of M/s. Niharika Electric Works (Enlisted Agency of WBSEDCL) inspected the premises of Sandip Karmakar and held raid.

During raid and inspection it was detected that accused Sandip Karmakar is using electricity dishonestly by way of tapping the incoming service cable to bypass the proper registration of units in the Energy Meter of WBSEDCL. Through this bypass arrangement he is using Soldering Iron-1 No, LED- 2 Nos, Fan- 1 No & Sound System having connected load of 0.5 KW. The Service Connection of WBSEDCL bearing Consumer ID: 242068194 stands recorded in the name of the accused of that Service Connection which has been disconnected on detection of theft of Electricity.

I prepared Inspection report in presence of the Accused and assessed the Load as 0.5 Kw. Details have been mentioned in the Inspection Report duly signed by the Accused.

I directed Sri Sanjay Mahanty, Technical Staff of M/s. Niharika Electric Works (Enlisted Agency of WBSEDCL) to disconnect the Service Connection of the above stated Consumer ID. Accordingly he disconnected the aforesaid Service Connection and removed the energy meter along with bypass arrangement.

I prepared seizure list in presence of witnesses, details of seizure have been mentioned in the seizure list duly signed by the Accused. A copy of the seizure list was handed over to the accused. The Local people gathered there witnessed the incident but refused to sign on the Seizure list and inspection report.

For this activity of theft the WBSEDCL has sustained huge financial loss in terms of revenue.

It is well evident that the above mentioned accused person has committed offense u/s 135(i)(a) & 135(i)(b) of Electricity Act 2003 (Amended in 2007).

Kindly treat this complaint as FIR and take necessary action against the accused.
