Acting upon such information on 23.03.2022 from 12.10 PM to 12.30 PM I, along with Sri Manab Kr. Maji, J.E. Gr-II, Sri Arindam Chatterjee, Sr. O.E Balarampur CCC and technical persons of M/s. Niharika Electric Works (Enlisted Agency of WBSEDCL) inspected the premises of Sri Sarbeshwar Mahato and held raid.
