I do hereby lodge complaint empowered by enabling Te Electricity Act – 2003, subsequently Electricity (Amendment) Act 2007 to the effect that Paitiwiay Tudu S/o Ganesh Chandra Tudu of Village Jashpur was enjoying electricity dishonestly by means of direct hooking from nearest Low Tension Overhead Line and caused revenue loss of WBSEDCL. Has committed theft of electricity U/S 135/1/a of The Electricity Act 2007.
