**Sub:** Prayer for starting a specific case against one Joydeb Mudi (25+ yrs), S/O- Lt. Kalosona Mudi of Vill:-Bamundiha, PS- Bandwan, Dist-Purulia (Driver of Bolero Mahindra Jeep having Regd. No- JH-05AM/5679).

## Respected Sir,

With due respect I, ASI Sujit Mondal beg to submit before you that on 07/03/22 from 10.05 hrs and onwards myself along with force were performing Special mobile traffic duty in C/W Madhyamik Examination-2022 vide Bandwan PS Spl. CC No-20/22 Dated-07/03/2022. Then, at about 13.30 hrs at Chilla more under Bandwan PS, on Chilla-Kanshbahal pitch Road. I found one Bolero Mahindra Jeep which was coming from Chilla-side & going towards Kanshbahal side dangerously with excessive speed. We raised hand and directed him to stop the Bolero Mahindra Jeep. But, the said Bolero Mahindra Jeep driver, violated the Police Signal and endangering human life driven the vehicle by rush and negligently which may cause accident to the road user at any time. Accordingly, we started to follow the said offending vehicle and near the junction point to the Bandwan SBSTC bus stand, I found that the said vehicle already took entry into the vacant land in the road side field and the driver of the said vehicle was not in proper mental condition or probably in intoxicating condition. On interrogation, he made incoherent statement at different time and finally he disclosed his identity as Joydeb Mudi (25+ yrs), S/O- Lt. Kalosona Mudi of Vills-Bamundiha, PS-Bandwan, Dist-Purulia.

Hence, he violated the provision of Section 279 IPC, So I arrested the offending driver namely Joydeb Mudi (25+ yrs), S/O- Lt. Kalosona Mudi of Vill:-Bamundiha, PS-Bandwan, Dist-Purulia abiding by all the procedure as laid down in Cr.P.C and the latest guide lines of the Apex Court and seized the said Bolero Mahindra Jeep having Regd. No- JII-05AM/5679 from the possession of above noted driver of the said Bolero Mahindra Jeep under proper seizure list duly singed by him and other available Witnesses. As the offence is bail able I offered him bail but none were turn up before me at that time. On being asked he refused to undergo to medical check up. So finding no other any alternative way, I brought him into PS along with seized articles.

So, I pray before you that a specific case may kindly be registered against the accused namely Joydeb Mudi (25+ yrs), S/O- Lt. Kalosona Mudi of Vill:-Bamundiha, PS- Bandwan, Dist-Purulia (Driver of Bolero Mahindra Jeep having Regd. No- JH-05AM/5679) for committing offence U/S-279 IPC.
