**Subject:** Reporting hindrance of work, damage to property, Violence and trespassing at our mines site in the night of 04.03.22 around 10 PM.

Respected Sir,

With reference to the above subject I have to inform you that a group of 12-15 hooligans entered our mines and stopped our work and threatened our working staff of dire consequences. They were very loud and said "humara mines band karwa ke aapna chalayega". Our staff stopped the work and reported this matter to mines senior staff and me.

When our staff intervened, they hurled stones and started abusing our staff and one of our staff namely Deepankar Chattraj (In-charge staff, designation:- Mining Mate) of our aforesaid mines was beaten badly by these people. They attacked him in his neck and tried to strangulated him, suffocated him to near death. He succumbed to his injury and became unconscious. They did not stopped here and they tried to break open our mines office lock, they started damaging our mines property, broken some of the nearby lights, wash basin etc. of our office building and broken front glass of our bolero vehicle and excavator parked nearby. They tried to damage our all other machineries with iron rods and whatever came in front of them.

After the incidence our staffs could recognize that one person named Tonu who is the manager of Mr. Bansidhar Banerjee, has beaten our staff and also taken away his mobile phone in clandestine manner. With the help of the administration our man was shifted for treatment. Our working staff is still traumatized with this violent incidence and in great fear.

In the night I went there personally to inspect the matter and while I was entering towards our mines road I found one Scorpio car bearing registration number JH05AB6886 coming out from Dhargram more. I saw 3-4 persons inside the vehicle and I can recognize them as Mr.

Gangadhar Singh, Mr. Bob, and Chandan Singh among them. All of them belong to Barabazar. As soon as I appeared they left towards Taladih.

I also want to report that while in our mines area one vehicle bearing registration number WB37C 2242 of Mr Banshidhar Banerjee was parked intentionally from opposite direction to block the one way outgoing road and to stop the flow of traffic. I immediately returned back from there.

I strongly believe that this incidence is a result of the provocation of illegal mines handlers like Mr. Narayan Pandey and above noted persons. They abetted the villagers along with their staff and deputed them to cause this nuisance and violent damage at mines.

Under the circumstances I want to inform you about the matter and request your good self to take necessary legal action against the above noted namely people and others who committed this violence. I also request to provide necessary protection to our workmen and property.

I request you to kindly do the needful so that we can stay safe at mines site and work peacefully. Your immediate action in the matter will be highly appreciated.
