I do hereby lodge complaint, empowered by enabling "The Electricity Act, 2003" subsequently electricity act-2007, to the effect that JUDHISTHIR MURMU Vill- BABUIJHOR, Dist- Purulia was enjoying electricity illegally by by-passing the Single Phase Energy Meter (SI No- 0162660) From its incoming Service Cable through 01-Core PVC wire and he has committed theft of electricity U/S 135(1)/b of the electricity (Amendment act-2007).

On 25.03.2021, I Sri BANTI KARMAKAR, A.E & S.M, BARABAZAR CCC, WBSEDCL along with

At About 12:02 P.M., entered into the premises of JUDHISTHIR MURMU Vill- BABUIJHOR, Dist- Purulia and inspected his premises at Vill.- BABUIJHOR, P.S Barabazar, DIST- Purulia.

During inspection, it was found that JUDHISTHIR MURMU Vill- BABUIJHOR, P.S- Barabazar, Dist.- Purulia was enjoying electricity illegally by by-passing the Single Phase Energy Meter (SI No- 0162660) From its incoming Service Cable through 01-Core PVC wire in his premises at BABUIJHOR having connected load 0.117 KVA.

From the above he was using the following arrangements:

I seized the following articles from the said premises:
