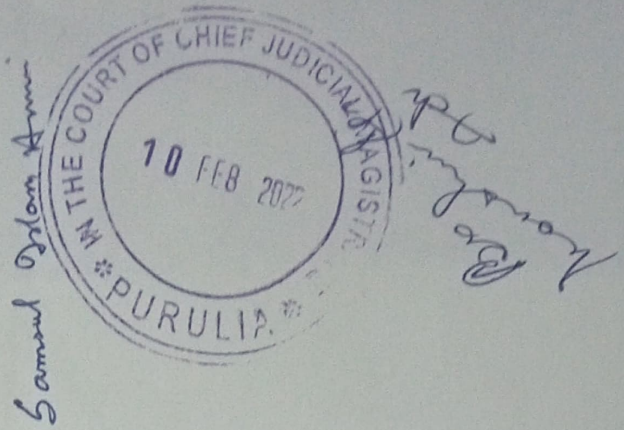
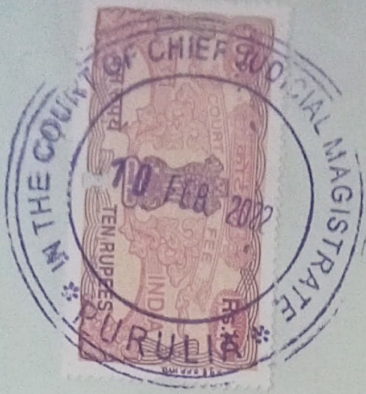

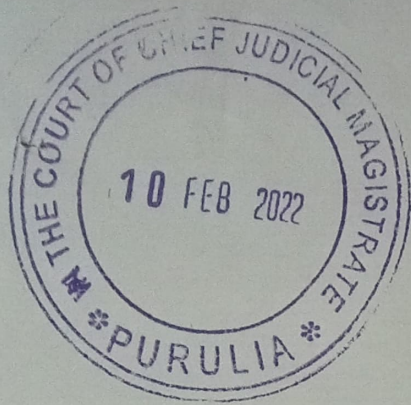

Most respectfully begs to state:

1. That the Complainant, Accused Person and the Witnesses No.2 to 3 are the permanent resident of Village Hijuli having their residential houses therein.
2. That on 28/10/2021 after 6 PM, the Accused Person was returning from Purulia along with his wife namely Tahera Parveen (i.e. the daughter of the Complainant) in a motorcycle being No.WB-56Q-0899 to their house through Purulia-Bankura Road (NH-60A).


3. That when the motorcycle crossed Kulgora More within Hura P.S. suddenly the motorcycle met an accident due to very high speed, rough & negligent driving of the motorcycle by the Accused Person.
4. That due to such incident said Tahera Parveen sustained injury on her person and after the incident the witness No.2 & 3 who at that time were standing at Kulgora More, reached to the spot & they with the help of some local people took Tahera Parveen to Hura Hospital where the Witness No.4 referred her to higher centre. On hearing the incident the Complainant went to Hura Hospital.
5. That the Witness No.2 & 3 & the Complainant took Tahera Parveen to Purulia Deben Mahato Medical College & Hospital, where the Witness No.5, declared her as dead.
6. That the incident occurred due to high speed of the motorcycle and the rough & negligent driving by the Accused Person.
7. That the Complainant thereafter on several occasions met the O/C Hura P.S. informing all about the incident & requesting him to take steps against the Accused Person but the police did not take any action in the matter up-till now.
8. That the Complainant also informed the matter to the S.P. Purulia on 17/01/2022 but up-till now no action has been taken by the police.
9. That thus the Complainant brought this case for the offences committed by the Accused Person for which he is liable to be prosecuted.

It is therefore prayed that your honour may graciously be pleased to treat this petition as a Complaint under Section-156(3) of the Cr.P.C. & send the petition to the O/C Hura P.S. for investigation & further be pleased to pass necessary order.
