Hearing this I was astonished as I did not execute any Agreement for Sale in respect of my said property in favour of any person at any point of time, and so to know the matter on 23-03-2022 I along with my husband went to the Bank of India, Katjuri Danga Branch, Bankura and met with the Branch Manager and came to know from him that a loan has been sanctioned by him in the name of said Amiya Mandal on the basis of an Agreement dated 02-03-2022 executed before Hafizur Rahaman, Notary Public Regn. No. 45/2002 at Bankura Court, P.O. & Dist. Bankura (W.B.)
