Sub: To start a specific case.

Sir,

I ASI Dinabandhu Bauri of Jhalda PS, Dist-Purulia do hereby lodge a suomoto complain after arriving at PS that today 14.03.2022 I along with force was performing Picket duty at the Jhalda Old PS Compound Gate vide Jhalda PS GDE No-541 dtd-14.03.2022 and Jhalda PS CC No-682/2022 dtd-14.03.2022 . During performing the duty, I saw that a procession of about 2000/2500 people for the purpose of the cremation of the dead body of INC leader Tapan Kandu was coming from Jhalda Bus Stand Side. Subsequently I was engaged to clear up the traffic congestion so that the procession could cross the parochial road smoothly. As soon as that procession crossed the Old PS gate, in a jiff, an unruly mob of 40/50 persons from the tail end of that procession came out and pushed and kicked on the Old PS Main gate at about 17 :15 hrs. Subsequently, I asked them to abstain from that illegal act but they did not pay any heed to my words. Thereafter, the unruly mob entered into the Jhalda Old PS Compound by breaking the Main Gate as well as pushing us aside and damaged 2/3 Motor cycles and one Police pilot vehicle hitting with big stone and lathi, which were parked inside the compound. The members of that unruly mob were also pelting stones aiming at us and blocked the road for 10 mins. I found that the Ranchi - Jhalda road has been blocked by them after forming un-law full assembly. Subsequently I saw some of the members of that unruly mob threatened the drivers of the vehicle with dire consequences by lathi if they tried to move the vehicles. The vehicular traffic was totally disrupted and seized along the Purulia-Ranchi road. Thereafter, I informed the matter to you. Despite of all I persuaded further and tried to convince but the unruly mob obstructed us adamantly from the discharge of our public functions. Latter they dispersed from there 17:25 hrs. Thereafter, the vehicular traffic movement became normal after our assiduous act. As the unruly mob committed offence U/S 143/186/283/427/506 IPC & 18 W.B Highway act 1964 and read with section 9 MPO Act and 3 of PDPP Act so, I submitted suomoto complain against the them before your good self to start specific case against them.
