Sub: To start a specific case.

Sir,

I ASI Dinabandhu Bauri of Jhalda PS, Dist-Purulia do hereby lodge a suo moto complaint after arriving at PS that today 16.03.2022 I along with force was performing Day mobile duty at PS area vide Jhalda PS GDE No- 614 dtd- 16/03/2022 and in consonance with CC No- 694/2022 dtd- 16/03/2022 received a telephonic information from duty officer of Jhalda PS regarding a procession of CPIM Party was proceeding from Bandhaghat CPIM Party office towards Birsha More by obstructing State Highway (SH-4A). Immediately after receiving the information I along with force rushed towards Bandhaghat after being instructed by I.C Jhalda PS with Govt. vehicle WB56C/8741. As soon as I arrived at Bandhaghat at about 16.55 hrs, I found that a procession of CPIM Party with flags and festoons consisted of 120 to 150 was going towards Birsha More. I also found that rally was proceeding towards Birsha more, covering the entire the State Highway (SH-4A) with their party slogan and slogan against Police. I tried to stop them to demand any valid permission of that rally but none of the members of rally stopped and disobeyed my order and refused to give any kind of information. It could be presumed that the rally had been conducted without permission. I tried to identify the leaders but I could not able to identify any of them. The vehicular traffic was almost disrupted along the Purulia-Ranchi road especially the municipality area (SH-4A). Thereafter, I informed the matter to you and you also confirmed me the rally was being conducted without any valid permission from proper authority. Subsequently I diverted some of those vehicles towards the bypass road to avoid congestion along the State Highway as the road is one of the busy public lines of navigation of this district. Latter, while the rally arrived at Birsha More at about 17.35 hrs the vehicular traffic movement became normal after our assiduous act. As the members of the rally committed offence u/s 283 IPC & 18 W.B Highway Act. 1964 & read with section 32 Police Act ergo, I submitted suo moto complain before your good self to start specific case against the unknown 120-150 members of the procession of CPIM Party who conducted rally without permission .
