In producing herewith the driver namely Mansu Gope (48), S/o- Rathu Gope of Village- Talmu, Ps- Joypur, Dist. – Purulia, along with seized vehicle (tractor) bearing Having Eng No:- 3100DL43L467436F3 & Chassis No:- BZQSU470331SM, attached with Seizure List and Memo of Arrest.

The nub of the fact in a nutshell is that today (05.03.2022) while I, SI Maniur Rahaman along with C/698 Shashadhar Mahato & C/1389 Debnath Roy, left Baglata Investigation Centre to perform evening mobile duty (vide Baglata I.C. GDE no. 139, dated- 05.03.2022 & CC No- 414/22), in Baglata I.C. area. During my evening mobile duty I, received a tip off at 16:05 hrs that a suspicious tractor loaded with sand was coming from Talmu village toward Mayadih Village under Joypur PS. Subsequently, I along with force proceeded toward Talmu village to work out the tip off. While, I along with force arrived near Talmu village more and found that one tractor was proceeding towards Mayadih Village. I, along with force intercepted the vehicle (Blue Colour Tractor) without Reg. number, attached with trolley loaded with sand. On being asked, the driver of the said vehicle discloses his name as noted above. I, asked the driver of the vehicle to produce the valid document in respect of the vehicle as well as the loaded sand. But the driver of the said vehicle could not able to produce any kind of documents in respect of the tractor and the sand. I, repeatedly asked the driver to produce the valid paper but he stated differently in different time. The in-coherent statement of the driver purported to be suspicious one to us. It was ascertained that the driver of the said tractor loaded the said sand in cahoots with the owner of the vehicle by illegal means for selling the same to make profit by dishonestly and they had been running a clandestine business. So, it is reason to believe that they in cahoots with the owner of the vehicle procured the said sand from Izri River near Sidhi village side by fraudulently means or theft by any means for transporting the same to run clandestine business. So, I seized the blue colour tractor Having Eng No:- 3100DL43L467436F3 & Chassis No:- BZQSU470331SM, attached with the trolley loaded with sand under proper seizure list in presence of available witnesses duly signed by them in between 16.45hrs & 17.15hrs and also arrested the driver namely Mansu Gope (48), S/o- Rathu Gope of Village- Talmu, Ps- Joypur, Dist. -Purulia at 17.20hrs, after informing the ground of his arrest and issued Memo of arrest against him. Thereafter I brought the seized tractor to Baglata I.C under Joypur PS.

Under above fact and circumstances kindly take lawful action against the driver namely Mansu Gope (48), S/o- Rathu Gope of Village- Talmu, Ps- Joypur, Dist. – Purulia, and the owner of the vehicle as the committed offence U/S 379/411/414/120B IPC and 21(i)(4) of Mines and Minerals (R&D) Act – 1995.
