In producing herewith 01 (one) arrested accused person namely Fulchand Sahis (25 yrs) S/o-Bhairab Sahis of Vill-Ranibandh, PS-Purulia (M), Dist-Purulia along with seized one red colour tractor having Regd. No-JH09AS-4870 loaded with sand (100 CFT approx) under proper seizure list, I beg to submit that today (09/03/2022) I ASI Tarapada Hazari along with (1) C/-1492 Dilip Gorain (2) C/-842 Angshuman Tewari both of Joypur P.S were performing Special Mobile duty vide Joypur PS CC No-740 Date-09/03/2022. During my mobile duty at about 14:35 hrs received a credible source information that one tractor loaded with sand is coming from Jabkadih river bed, I along with force reached at Jabkadih village under Joypur PS and found that a tractor having Regd. No- JH09AS-4870 loaded with sand was coming from Jabkadih river bed side. On seeing the Police party at Jabkadih more, the driver of the said tractor were trying to fled away. But after a hot chase, we could able to detain the driver of said tractor having Regd. No-JH09AS-4870. On integration he made incoherent statement at different time. He disclosed his identity as Fulchand Sahis. I asked the driver Fulchand Sahis to produce valid documents in respect of said sand but he failed to produce any documents regarding lifting & transportation of sand. I interrogated him thoroughly. During interrogation, he admit that he and owner of the said tractor dealing with illegal sand lifting from Kangsabati riverbed and transporting the sand. The driver also failed to produce any paper in respect of the tractor. Hence, I seized the one red colour tractor having Regd. No-JH09AS-4870 loaded with sand (100 CFT approx) in between 15:25 hrs to 15:45 hrs under proper seizure list in presence of available witnesses duly signed by them and I arrested Fulchand Sahis (25 yrs) S/o-Bhairab Sahis of Vill-Ranibandh. PS-Purulia (M), Dist-Purulia. After observing all formalities & disclosed him about the ground of arrest. I brought the said tractor to Joypur P.S. As such there is every reason to believe that the driver & owner of the said tractor is dealing with sand illegally and transporting with ill motive without any valid document.

So he is liable for offence punishable U/S- 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against Fulchand Sahis (25 yrs) S/o-Bhairab Sahis of Vill-Ranibandh, PS-Purulia (M), Dist-Purulia & owner of the tractor having Regd. No-JH09AS-4870 may kindly be started and arrange for its investigation.
