Sir,

In producing here with the accused persons namely (1) Akbar Ansari (50 yrs) S/o-Late Gulam Ansari (2) Jibrayel Ansari (32 yrs) S/o-Nejam Ansari (3) Kalam Ansari (40 yrs) S/o-Kadir Ansari all of Telo (Mirchatand) PS-Chandrapura Dist-Bokaro (Jharkhand) brought under arrest along with seized articles as per seizure list i.e. one improvised country made 9 MM Pistol fire arms (Iron made) having Iron butt, body, barrel, trigger, firing pin etc, 04 (four) rounds live ammunition and one Motor Cycle bearing Regd. No-JH10AR-3888. (Hero Passion Pro Black & White Combination) I, ASI Tarapada Hazari of Joypur PS do hereby lodged a written complaint against the above noted accused persons to the effect that on 28/03/2022 at 18:05 hrs while myself along with C/-2217 Souvik Rana, C/-857 Chepulal Murmu & C/-997 Rajkumar Bauri (Joypur PS GDE No-1334 Dated-28/03/2022 & CC No.1407/22) & CV/-2307 Ananda Mahato, CV/-2339 Bivash Mahato all of Joypur PS were engaged in Naka checking duty at Kathaltard strategic point at Jharkhand Border on Purulia -Bokaro Pitch Road (NH-32) under Joypur PS Dist-Purulia and found the above noted person was coming from Pindrajora Side via NH-32 towards Kathaltard riding on Motor Cycle and on seeing the Naka Checking party they tried to run away. Immediately the checking team apprehended them at Kathaltard Naka Checking Point. I asked them why they tried to flee away. Then they made incoherent statement. I searched them on the spot and found improvised country made 9 MM Pistol fire arms loaded with one round live ammunition which was kept in the left side of the waist concealed under the shirt of Akbar Ansari who was seated at the middle of the Motor Cycle, one round live ammunition was recovered from rider Jibrayel Ansari & 02 round live ammunition recovered from exclusive possession of Kalam Ansari pillion rider of the Motor Cycle. On demand of papers they failed to produce any papers / documents in support of carrying / possessing of such fire arms and ammunition. On interrogation they disclosed their identity as noted above and made incoherent statement in respect of their presence at that place and also the purpose of possessing said fire arm and ammunition. So it is reasonable to believe they chose the said route pre-planningly to commit any cognizable offence at Bartard Hat on Purulia-Bokaro Road (NH-32). I seized the said fire arms and ammunition under proper seizure list in presence of witnesses as well as accused persons and make over one copy of the seizure list to them and they put their signature as token of acknowledgement and also labeled the same by me. I tried my label best to sign the public witnesses but none is willing to put their signature on the seizure list as the accused is a veteran criminal of Bokaro dist area. So I unable to put signature of any public witnesses on the seizure list. Hence I arrested them abiding by all the procedure as laid down in C.rPC and the latest guidelines of the Apex Court as he has violated the provision of Arms Act, 1959.

I therefore pray that a specific case may kindly be started against the accused person namely (1) Akbar Ansari (50 yrs) S/o-Late Gulam Ansari (2) Jibrayel Ansari (32 yrs) S/o-Nejam Ansari (3) Kalam Ansari (40 yrs) S/o-Kadir Ansari all of Telo (Mirchatand) PS-Chandrapura Dist-Bokaro (Jharkhand) under proper section of law and arrange its regular investigation.
