This is to inform that at around 5.35 p.m on 06.03.2022, a vehicle with vehicle no. JH02 AA 4553 accidentally hit and damaged the Public property (1 no. Pole, associated conductor and other assecories) at Bhalukgajar road. Neither the Driver nor the Owner of the vehicle intimated after such accident. The owner of the vehicle visited this office and we served the Quotation with memo KSP/QUO/870 dated 07.03.2022 (attached herewith) for payment of Rs. 10,304/- but till now the payment has not been received.

Hence FIR needs to be raised against the Driver and Owner of the vehicle to recover the damage of Public property at this end as per Electricity Act 2003 under Section 135 - 1(c).
