Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity U/S-135(1)(a Electricity (Amendment) Act-2007 to the effect that Sri Prasanta Kumar Mandal S/o Kinkar Mandal, Vill-Patpur, PO-Malancha, PS- Kashipur, Dist-Purulia has committed theft of electricity by means of hooking from service cable.

On dated 14.03.2022, about 3.35 p.m. while performing site inspection of LT Line at Patpur area, I Sri Somnath Burman, Assistant Engineer(E) & Station Manager, Kashipur Customer Care Centre, WBSEDCL along with subordinate attached to this office, Sri Gotirmoy Dass, JE(Grade-1), Kashipur CCC, LT mobile van staff attached to kashipur CCC, Sri Swapan Kumar Mahato (Skilled Worker) and Sri Sudip Chokroborty (Unskilled Worker) entered the premises of Sri Prasanta Kumar Mandal S/o Kinkar Mandal, Vill-Patpur, PO-Malancha, PS- Kashipur, Dist- Purulia, and found that there is meter vide consumer no-242205914 (which is physically disconnected on 28.02.2022 owing to non-payment of electric bill) but he is consuming electricity dishonestly by means of hooking from nearest It line of wbsedcl.

Total Load found approx 0.52 KW (Fan-2 nos. and Bulb-4 nos.)

Then we disconnect his hooking line, seized the following articles.

- 1)Hooking Wire with hooking device- --- 27 feet (approx.).
- 2) Bulb holder -1 no.
- 3) 100 W bulb-1 nos.

The seizure lists are prepared at the site and the representative of accused person sign in the seizer list. The inspection team left the above premises at about 3.55 P.M.

The accused person has committed an offence U/S-135(i)(a) of the Electricity (Amendment) Act-2007 for illegal theft of electricity.

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per rule.
