The complainant planted some trees like Arjun, Palas and Akhara near about forty years ago and now the said trees are big tree.
- 3) That on 23/08/2021 corresponding to 6th day of Bhadra 1428 B.S. at about 5/30 A.M. , the above named accused persons armed with deadly weapons, most illegally and wrongfully entered into the above mentioned land and

started cut the trees from the Bandh Ail hearing the news the complainant rushed to Bandh Ail and protested them of their illegal activity. But they did not pay any heed. And there after they removed the trees from the Bandh Ail. Seeing ^{NO} ~~the~~ alternative the complainant makes a noise by saying ~~Bandh~~ Bancho- Bancho, hearing the news the witnesses came there and saved the complainant from the hand of the accused persons. The witnesses named above saw the incident then the accused persons left the place with direconsequences the complainant sustained a loss of Rs. 40,000.00 only.

4) That on the same day the complainant went to ^{Kenda} ~~Kendabazar~~ P.S. and reported the matter to the duty officer of ~~Kenda~~ ^{Kenda} P.S. There after on dated 24/12/2021 reported the matter of S.P. Purulia but off no good. Thus the complainant has been compelled ^{to file} this case and this is the delay to file the case.

5) That accused persons have committed criminal offence and they are liable to punish accordingly.
