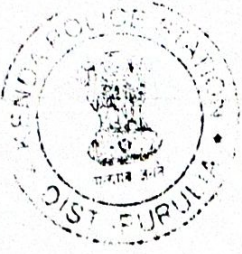

In producing herewith arrested accused person namely Balgovind Yadav (31 Yrs.), S/o- Revat Yadav of Vill- Sonbad, PO- Taratand, PS- Taratand, Dist- Giridih, Jharkhand along with one seized vehicle (Truck) having Reg. No. JH09M-7476, Chassis No. MAT466372A2C08118, Engine No- 6BTAA5901C2861452.

I beg to report that today myself along with C/315 Mir Kurban and HG /1923 Banamali Manki both of Kenda PS were performing day mobile duty at Punura Morh under Kenda PS area vide Kenda PS C.C No-371/22 dtd. 24/03/2022 and Kenda PS GDE No-780 dtd- 24/03/2022 at about 11:35 hrs, I found one Truck bearing Registration No- JH09M-7476 coming from Kenda side rashly and negligently. We try to stop him but the driver of the said truck named in above was trying to escape the place so rashly, there was every possibility of loss/ serious injury of nearby public due to his such driving. After a hot chase we could able to stop him near at Darodih More under Kenda PS. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life. So, I arrested him as he violated Sec. 279 IPC and I also seized the truck in presence of witnesses. His family member was also informed about the ground of arrest.

Therefore I pray that a specific case may kindly be start against accused Balgovind Yadav (31 Yrs.), S/o- Revat Yadav of Vill- Sonbad, PO- Taratand, PS- Taratand, Dist- Giridih, Jharkhand.
