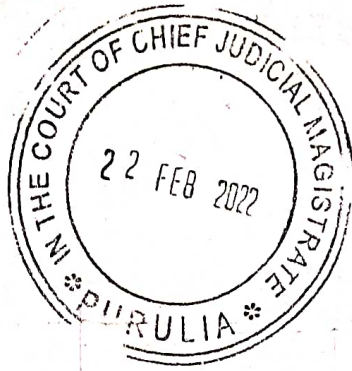

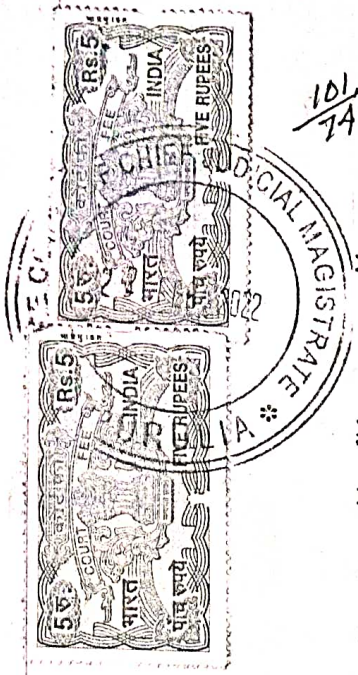

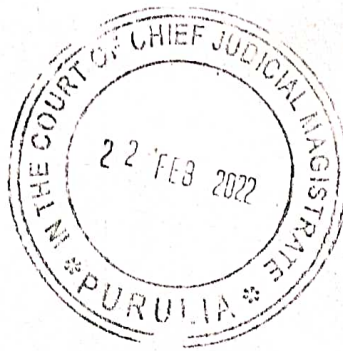
Most respectfully beg to state as follows:-

from his kheth but they did not listen, moreover they rush to the complainant with a view to assault the complainant with 'the Kastees' having those weapons in their hands ~~the~~ and they attempt~~d~~ to assault the complainant.

4. That thereafter, the all accused persons after cutting all paddy crops taken by tractor from the paddy kheth which are valued at Rs.40,000/- approx.

3. ~~That~~ the matter was informed to Kotshila P.S. but no action ~~wanted~~ was taken by Kotshila police so, the complainant lodged complain to S.P.Purulia about the occurrence dated 1.12.21 but yet did not take any action.

Under the aforesaid circumstances, it is clear that the all accused persons forcibly and illegally trespassed into the land of the complainant and cut the paddy crops and away the same from the kheth of the complainant and the~~y~~ they have jointly offences punishable ~~u/s. 447/379/~~ in ~~506/34~~ I.P.C. And accordingly they should be punished as per law.
