Sir,

In producing here with one accused person Anil Mahato (32) S/O Lt. Rangamoy Mahato of village Rakdih PS- Manbazar District Purulia along with following seized articles viz-

- 1) 18 (Eighteen) Ltrs ID liquor within a Jarikane.
- 2) 08 pces of plastic glass

I S.I. Goutam Kumar Mahata of Manbazar PS do here by lodged a complaint against accused namely Anil Mahato (32) S/O Lt. Rangamoy Mahato of village Rakdih PS- Manbazar District Purulia to the effect that today (15.03.2022) at 17:35 hrs. in course of my evening mobile duty vide Manbazar PS G.D.E. No.553 Dtd.15.03.2022. I received a telephonic information from a reliable source that one Anil Mahato (32) S/O Lt. Rangamoy Mahato of village Rakdih PS- Manbazar District Purulia was stocked ID liquor illegally and selling the same to hike price for his personal gain. I informed the matter to O/C Manbazar PS and as per order of O/C Manbazar PS myself along with C/638 Lalchand Bag NVE 537 Asit Kr Mahato rushed to the spot for raid by Govt. vehicle. At about 18:00 hrs. myself along with force reached at Rakdih village and held raid in the house of Anil Mahato (32) S/O Lt. Rangamoy Mahato of village Rakdih PS- Manbazar District Purulia and found that said house owner selling ID liquor at his own house and Seeing the police party some persons fled away and said Anil Mahato tried to concealed himself but we are able to apprehend him and also detained him. He asked him to produce valid license or valid papers for selling ID liquor, but he failed to produce any valid license or documents for possessing the same. So he arrested the above noted accused person informing the ground of arrest and seized the above mentioned articles after proper seizure list duly signed by accused person and available witnesses.

Hence, I therefore pray that a specific case may kindly be started against arrested accused person Anil Mahato (32) S/O Lt. Rangamoy Mahato of village Rakdih PS- Manbazar District Purulia as per law and arrange for its investigation.
