


Sir

With reference to the above mentioned subject, this is to inform that the Office of the Undersigned has conducted an inspection in Baragajari Ghat, after receiving telephonic message of the O/C Mining, Purulia. From the verification of the said sand mining ghat, it is revealed that the Lessee, namely Chittaranjan Mondal, has used machinery and boat on the said ghat for mining of Sand, but no such boat and machinery is found to be working during the time of inspection.


Therefore, the undersigned would like to lodge and F.I.R against the Lessee Chittaranjan Mondal for mining of sand, by using unauthorised machinery, at the said Baragajari Sand Mining Ghat which contravenes the provision under Sec 4(1A) of the Mines and Minerals (Development & Regulation) Act, 1957 read with 3(b) of the WBMM Concession Rules, 2016 and Rule 3 of the West Bengal Minerals (Prevention of illegal mining, transportation and storage) Rules, 2002.

The undersigned is duly authorized by the Government of West Bengal to lodge and F.I.R under section 22 of the Mines and Minerals (Regulation and Development) Act, 1957, in terms of Notification No. 89-GI/Gr-D/4M-30/88, dated 24.01.1991.
