In producing here with one accused person Bikash Bauri (22Yrs) S/O-Joydeb Bauri village
Madhabpur P.S. Manbazar, Dist – Purulia, along with following seized articles viz-

- (1) 10 (Ten) Ltrs ID liquor within a Plastic Jarikane
- (2) One Nylon Bag
- (3) 375 M.L ID liquor collect from the 10Ltrs Jarikane as sample

I S.I. Biswarup Roy of Manbazar PS hereby lodged a complaint against accused
namely Bikash Bauri (22Yrs) S/O-Joydeb Bauri village Madhabpur P.S. Manbazar, Dist –
Purulia, to the effect that today (17.03.22) at 17:55 hrs. I received a telephonic information
from a reliable source that one Bikash Bauri (22Yrs) S/O-Joydeb Bauri village Madhabpur
P.S. Manbazar, Dist – Purulia, is caring ID liquor illegally and selling the same to hike price
for his personal gain. Then I informed the matter to O/C Manbazar PS and as per order of
O/C Manbazar PS myself along with C/1316 Ujjal Mondal and HG-1419 Santanu Dutta
rushed to the spot for raid by Govt. vehicle. At about 18.45 hrs. myself along with force
reached at Subhasini Pally Near the house of Ramesh Bauri S/O- Manik Bauri P.S. Of
Subhasini Pally P.S- Manbazar Dist-Purulia and held raid found that Bikash Bauri waiting for
customer for selling ID liquor. Seeing the police Bikash Bauri tried to concealed himself but
we are able to apprehend him and also detained him. I asked him to produce valid license or
valid papers for selling ID liquor, but he failed to produce any valid license or documents for
possessing / selling the same. So I arrested the above noted accused person informing the
ground of arrest and seized the above mentioned articles after proper seizure list duly signed
by accused person and available witnesses.


Hence, I therefore pray that a specific case may kindly be started against arrested accused
