In producing herewith the driver namely 1) Bibhash Mahato (22 Yrs) S/O Binod Bihari Mahato of Vill-Tentla, PO- Piyalsole, PS- Manbazar, Dist- Purulia (WB) along with seized one vehicle (Tractor) Mahindra B275DI, vide its Reg. No. WB 55A/7087, ChassisNo-MBNABAEAKJRK01589 & Engine No-RJK2EAN0045 attached with Sand loaded Trolley (approx 100 CFT) and with Seizure list, Memo of Arrest and Inspection Memo in respect of the supra person before you.

The nub of the fact in a nutshell is that on 21.03.2022 at 21:45 hrs while I along with force 1) C/45 Samir Kr. Mahato and 2) C/1316 Ujjwal Mandal both of Manbazar PS left the PS for performing night mobile duty, vide Manbazer P.S C.C No 670/22 and GDE No- 805 dt- 21.03.2022 in PS area as per order. During my night mobile duty, I received a tip off from credible source at 22:25 hrs that a large scale theft of sand is going on from Charka/Ichadih Ghat at Kumari River bed from night time. I passed information to my O.C Manbazer P.S and as per his kind direction, I along with force left for working out the information. As per kind direction I along with force proceeded towards the spot to work out the information. While I along with force arrived at Charka/Ichadih Ghat found that 01 (one) tractor was proceeding from Charka/Ichadih Ghat at Kumari River bed side. I along with force intercepted the vehicle (Tractor) WB 55A/7087, ChassisNo-MBNABAEAKJRK01589 & EngineNo-RJK2EAN0045 attached with Trolley loaded with Sand at 23:05 hrs and on being found the police party one person manage to escape from that anticipated place. I found the vehicle as well as goods as identical as I received prior information. On being asked, the driver of the said vehicle disclosed his name as noted in the above and disclosed the owner namely Ajoy Kumar Mahato S/O Mukunda @ Muku Mahato of village- Ichadih, PS- Manbazar, Dist-Purulia who fled away after seeing the police party and both were cogently illegally lifting sand from Charka/Ichadih Ghat at Kumari River bed. I asked the driver of the vehicle to produce the valid documents in respect of the vehicle as well as the loaded sand. But the driver of the said vehicle could not able to produce any kind of documents in respect of the Tractor and the sand. I repeatedly asked the driver to produce the valid paper but he stated differently in different times. The incoherent statement of the driver purported to be a suspicious to us. It was ascertained that the driver of the tractor loaded the said sand in cahoots with the owner of the vehicle by illegal sand lifting means for selling the same to make profit by dishonestly and he have been running a clandestine business. So it is reasoned to belief that he (driver) in cahoots with the owner of the vehicle procured the said sand form Charka/Ichadih Ghat at Kumari River bed by fraudulently means or theft by any means for transporting the same to run clandestine business.



So I. seized the WB SSA/7087 ChassisNo-MBNABAEAKIRK01589 & Engine No-RIKZEAN0045 attached with Trolley loaded with Sand under proper seizure list in presence of available witnesses duly signed by him. I also arrested the driver namely I) Bibhash Mahato (22 Yrs) S. O. Binod Bihari Mahato of Vill- Tentla. PO- Piyalsole, PS- Manbazar. Dist- Purulia after informing the ground of his arrest and issued Memo of Arrest and Inspection Memo against him. Thereafter. I brought the seized tractor to Manbazar PS compound.

Under the above facts and circumstances kindly take lawful action against and the drivers namely 11 Bibhash Mahato (22 Yrs.) S/O Binod Bihar. Mahato of Tentla. PO-Piyalsole. PS- Manbazar. Dist-Purulia and 21 owner of the vehicle (WB 55A/7087) namely Ajoy Kumar Mahato S/O Mukunda @ Muku Mahato of village- Ichadih. PS-Manbazar. Dist-Purulia as he committed offence U/S- 379/411/413/414 of the IPC & 21(1) (4) of Mines and Minerals (R&D) Act-1957.
