Sub:- Complain for starting a specific case .

Sir,

In producing herewith three arrested accused persons namely (1) Kashinath Bauri (28 Years) S/O- Mangal Bauri of Vill-Parbelia, PS-Neturia, Dist-Purulia (Driver of vehicle No- WB 81/2039) (2) Ajoy Hansda (19 Years) S/O- Raju Hansda of Vill- Parbelia, PS-Neturia, Dist-Purulia (Driver of vehicle No- WB 81/2091) and (3) Munna Bauri (29 Years) S/O- Lt. Subhankar Bauri of Vill-Neturia, PS-Neturia, Dist-Purulia (Driver of vehicle No- WB 81/0068) along with seized tractors having registration numbers (1) WB 81/2039 (2) WB 81/2091 and (3) WB 81/0068 along with trolley loaded with sand approx 100 Cft in each tractors under proper seizure list. I beg to submit that I, SI Abhijit Das, along with C/3180 Ratan Nayek, C/1319 Soumen Koley and C/939 Laltu Paul all are of Neturia PS were performing day mobile duty vide Neturia PS GD No- 1269 Dt. 28.02.22 at Parbelia side and at about 17:15 hrs received a credible source information that three tractors were loading sand illegally at Chinakuri Ghat under Neturia PS. I immediately intimated to you over phone and acquainted you about the information and you directed me to work out the information. As per your direction I along with force immediately started to move towards Chinakuri Ghat and at about 17:45 hrs we reached at Chinakuri Ghat and found the above noted tractors were coming towards us. Accordingly I indicated the drivers to stop the tractors and found the tractors are loaded with sand approx 100 Cft. in each tractor. On being asked the drivers of all the three tractors, they failed to produce the documents/Challan in respect of loaded sand and also failed to produce the documents in respect of tractors. On being asked they disclosed their identity as noted above and stated that (1) Sk. Azhar S/O- Sk. Isu of Vill-Nimdanga, PS-Neturia, Dist- Purulia (Owner of vehicle No- WB 81/2039) (2) Shyamal Bauri S/O- Meghnath Bauri of Vill-Gram Parbelia, PS-Neturia, Dist-Purulia (Owner of vehicle No- WB 81/2091) and (3) Bula Pandey S/O- Lt. Shaktipada Pandey of Vill+PS-Neturia, Dist-Purulia (Owner of vehicle No- WB 81/0068) are the registered owners of the seized tractors. On preliminary enquiry and as per their statements it could be learnt that they procured the said sand from the Damodar River bed at Chinakuri Ghat illegally as per order of the registered owners of the above noted tractors.

So, there is reason to believe that the drivers as well as registered owners of the above noted tractors have loaded the sand by theft or by any fraudulent means and after hatching a criminal conspiracy, they were trying to dispose off the same sand in a clandestine manner to different areas knowing it to be stolen.

Accordingly, I seized the Tractors having registration No- (1) WB 81/2039 (2) WB 81/2091 and (3) WB 81/0068 along with trolley loaded with sand approx 100 Cft in each tractors under proper seizure list duly signed by them and witnesses and also arrested the above noted drivers after preparing arrest memo. In course of arrest I notified them ground of arrest, issued arrest memo U/S-50 Cr.PC. Brought them PS with seized tractors along with trolley loaded sand .So, the drivers as well as registered owners of the tractors have committed offence U/S- 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (Development and Regulation) Act-1957.

Under the above facts and circumstances a specific case may kindly be started against drivers and registered owners of the above noted seized tractors U/S- 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (Development and Regulation) Act-1957 and arrange its investigation.
