Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that **Sri Manas Kabi, S/O-Lt Himangshu Kabi**, a permanent resident of **Vill- Hijuly P.O -Saltore, P.S -Neturia, Dist- Purulia** has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On **24.03.2022** at about **03:30PM** I, Dhritiman Sardar S/O- Rupal Sardar, aged about 24 years, AE & SM Saltore CCC, along with Sri Souvik Mudi, J.E. (Gr-II), Saltore CCC, Satya Rajwar, HgTSH, Saltore CCC, and others had been to the village: Hijuly for routine inspection purpose. During inspection it was found that **Sri Manas Kabi** was consuming electricity dishonestly and unauthorisedly in his domestic premises having GPS co-ordinates 23.676234,86.815662 by the way of direct hooking for meter bypaasing from the nearby LT mains of WBSEDCL so that less energy consumption recorded in energy meter which resulted causing loss of revenue of WBSEDCL in respect of **Consumer ID- 242036453 ,Meter NO-SL017500** to the tune of load **0.75KVA**.

As theft of electricity was detected during inspection the illegal hooking line was disconnected & removed from the nearby electrical source and one number two core flat type black coloured 4 sqmm alluminium core PVC cable along with hooking devices of assorted size has been seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list but the accused person denied by putting his signature in the Notice, Seizure List, Inspection Report and label. The above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representatives but the accused person refrain to sign the same. After completion of inspection, the inspection team left the aforesaid premises at about **04:00PM**.

Thus the accused **Sri Manas Kabi, S/O-Lt Himangshu Kabi, Vill- Hijuly P.O - Saltore,P.S -Neturia, Dist- Purulia** have committed an offence **u/s 135(i)(b)** of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR.
