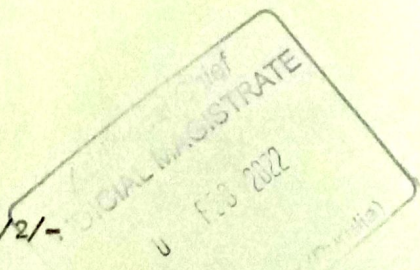

1. That the complainant namely Sitaram Mahato S/o Late Malati Mahato of Vill: Kaluhar, P.S.Para, District-Purulia engaged in digging sai in his garden along with Paltu Rajoar in that same ~~adren~~ adren on 17/11/21at about 2 P.M.
2. That the accused person namely Doctor Mahato S/o Babirani Mahato of the same village- Kaluhar, suddenly attacked on the complainant with a sharp axe by trespassing criminally in the garden of the complainant .
3. That seeing the accused person with the sharp cutting axe trying to attack upon the complainant for murder the complainant trie to fled away out of fear and fell down on that land of the garden.
4. That the accused person saw that the complainant fell down and he tried attack upon the complainant with the axe for murder but Paltu Rajoar saved the complainant by snatching that axe from the accused person and thereafter the accused person attacked with fiests blow upon the complainant and badly injured him as thes wrist of his left hand broken by axe and his under garments (Ganji) also ~~tored~~ torn by the accused person.
5. That son how the complainant managed to escape from the P.O. and saved his life from the accused person but the accused person threatened the complainant with dire consequences.
6. That the incident complainant was badly injured by the attack of axe and his left hand wrist fractured and his chest got injured (with pain by that brutal attack as such the complainant treated himself firstly in Para B.P.H.C; then Kustaur B.P.H.C.and lastly in Deben Mahato Sadar Hospital , Purulia on 17/11/21, 20/11/21 and 25/11/21 respectively.

7. That on 17/11/2021 the complainant had been to Para P.S. with a specific written complaint against the accused person for lodging complaint and to punish the accused person according to law.

8. That the Para P.S. took no steps in the matter of the complaint as such on 14/12/21 a copy of complaint sent to S.P. Purulia office for taking necessary action after lodging the F.I.R in Para P.S. but no 16/12/2021 in S.P. office this copy of complaint received but till now no F.I.R lodged and no action taken in this matter.

9. That there is a prima-facie case of criminal trespass accused person armed with deadly weapon (sharp axe) and attempt to murder upon the complainant unlawful restrained and causing gravious hurt upon the complainant as the left hand wrist of the complainant fractured and the garments of complainant tared and threatened him with dire consequence (Criminal intimidation) mischief (tare the ganji of complainant).

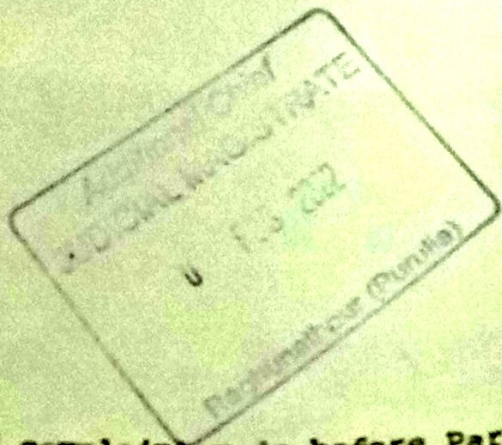
