Dear Sir,

I do hereby lodge a complaint being empowered by the Electricity Act. 2003 to the effect that **JAHIR ANSARY, S/O-ALIMUDDIN ANSARY** of VILL-Chalunia, Po-Bagalmari P.S.-Para, Dist-Purulia, the user of the electric has committed an offence of theft of electricity under section 135 (1) (a) of Electricity Act. 2003 read with amendment of Electricity Act. 2007.

On 17.03.2022 at about 03:37 PM to 03:40 PM I DEBABRATA DAS, S/O- LT Belyanath Das, AE & Station Manager of DUBRA PARA C.C.C, along with Mr.Patit Kora, S/O- LT Atul Kora , HG TSH , Dubra Para CCC ,Mr Bhaktipada Mahato S/O- LT Bajendranath Mahato, TSH of Dubra Para CCC , Probod Karmakar, S/O- Lt Kalipada Karmakar , (LT van, Supervisor)of B-shift Technical team inspected the premises of **JAHIR ANSARY, S/O- ALIMUDDIN ANSARY** of VILL- Chalunia, Po-Bagalmari P.S.-Para, Dist-Purulia . During inspection and it was found that the said **JAHIR ANSARY** was enjoying unauthorized electricity by hooking arrangement from WBSEDCL's nearest low tension over head line for running his 06nos 60 W bulb , 01 no table fan, approx. load 0.420KW for domestic purpose, which is an offence u/s. 135 (1)(a)of Electricity Act. 2003 read with the amendment of Electricity Act. 2007.

As electricity theft was detected, his service line has been disconnected and seized as token and labeled by preparing Seizure list at site. Due to theft of electricity a loss of revenue was incurred to the WBSEDCL. The whole operation took near about 15 minutes and we left the site at about 03:52PM to 03:55 PM

As such **JAHIR ANSARY, S/O-ALIMUDDIN ANSARY** of VILL-Chalunia, Po-Bagalmari,P.S.-Para, Dist- Purulia has committed an offence of theft of electricity under section 135 (1)(a) of Electricity Act. 2003 read with amendment of Electricity Act. 2007So, you are requested to take cognizance of this offence of theft of electricity treating this complaint as F.I.R.
