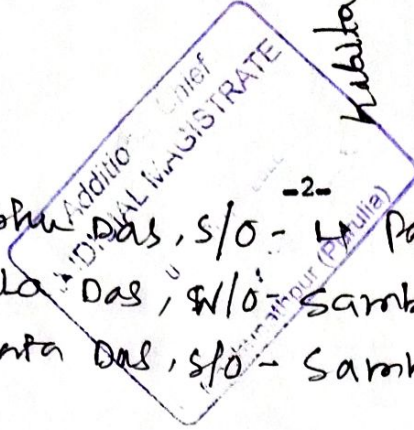

The complainant most respectfully begs to submit as follows:-

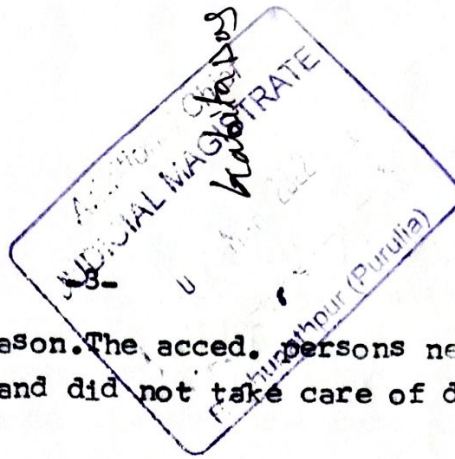
1. That the complainant is the legally married wife of one accused. person Pappu Ruhidas and their marriage was solemnized on 01-11-2020 according to Hindu rites and customs and usages as prevalent in their community in presence of parents, relatives of both parties.

2. That the time of marriage between the complainant and accd. persons, it is pertinent to mention the parents of the complainant gave a cash of RS:-1,00,000/- (Rupees One lakhs only) along with gold and silver ornaments, utensils, furniture etc. to the O.P. member/accused persons as a bridal gift.

3. That since after marriage the complainant went her matrimonial home as usually and started to live with accused person as husband and wife in a same mess.

4. That after months of their marriage when the petitioner was conceived out of the wed-lock the accd. person-1 at instigation of other accd. persons started torture physically and mentally

without cogent reason. The accd. persons neglected always even kept her starved and did not take care of during her pregnancy period.

5. That suddenly the complainant was sent to her paternal house by the accd. person-1 instigated by other accd. persons and while living at paternal house under care and treatment of the parents of the complainant, thereafter the complainant was blessed with twin baby girl in the Purulia Sadar Hospital on ~~18-12-2021~~.

6. That after few months, the complainant alongwith her sucking twin baby accompanied by her father reached to her matrimonial house on 18-12-2021. But after days, the accd. persons told to the complainant to demand 50,000/- (Rupees Fifty thousand) only from her father for looking after of their twin baby girl.

7. That father of the petitioner was unable to arrange the said illegal demand, as a result the complainant was subjected to torture mentally and physically by the accd. persons as previously.

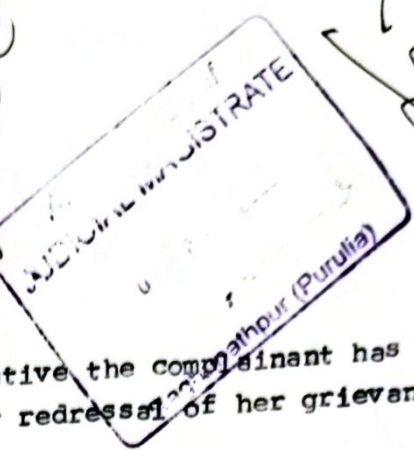
8. That the complainant went to para police station, on to lodge the written complainant where the concerned authority/ Police officer informed the complainant to take shelter of the court.
