Respected Sir,

In producing herewith one accused person namely Joydev Sarnakar (29yrs) S/O Lt. Sitaram Sarnakar of vill. Bhalkuriya, PS Para, Dist. Purulia along with seized articles 19 (Nineteen) pcs sealed bottles of Country Spirit styled as "DIL KHUSH" each Bottle contains 600 ml in which 01 (one) bottle as sample, and 1 (One) Black and Red colour Hero motorcycle without registration number along with seizure list and sample bottle from the same I write to inform you that today (22.03.2022) at about 18.55 hrs. I received secret source information from my reliable source that one person was carrying Country Spirit from Dubra side towards Santaidih at Koldih More. I informed the entire matter to O.C Para PS and as per his direction myself along with C/351 Kanailal Bauri, C/961 Himanshu Sannigrahi & NVF/ 487 Kirtan Singh Sardar all of Para Ps vide Para Ps C.C. No. - 702/22 dated 22.03.2022 left for Koldih more. When we reached at Koldih More and found that one person was coming riding on a motor cycle from Dubra side. Seeing police party he tried to flee away but was apprehended after a short chase, I apprehend the aforesaid person with his motor cycle without registration number and 19 (Nineteen) pcs sealed bottles of Country Spirit styled as "DIL KHUSH" each Bottle contains 600 ml. On demand he failed to produce any valid license and papers for possessing the said quantity of Country Spirit. So it was reasonably believed that Joydev Sarnakar (29yrs) S/O Lt. Sitaram Sarnakar of vill. Bhalkuriya, PS Para, Dist. Purulia was running his illegal business of Country Spirit at Udaypur G.P area and local people used to consume liquor from him for his illegal gain and loss. I seized 19 (Nineteen) pcs sealed bottles of Country Spirit styled as "DIL KHUSH" each Bottle contains 600 ml in which 01 (one) bottle as sample and 1 (One) Black and Red colour Hero motorcycle without registration number under proper seizure list in presence of witnesses. I also tried for local witnesses but none turn up. I also arrested him after stating him cause of his arrest maintaining all legal formalities and prepared sample bottle for laboratory test and issued memo of arrest on 22.03.2022 at 19.35 hrs.

The above noted arrested accd. namely Joydev Sarnakar (29yrs) S/O Lt. Sitaram Sarnakar of vill. Bhalkuriya, PS Para, Dist. Purulia committed offence u/s 46 A(c) B.E. Act. 1909 for unauthorized possession and sale of said liquors.

Under the above fact and circumstance I therefore pray that a case u/s 46A(c) B.E. Act'1909 may kindly be started against Joydev Sarnakar (29yrs) S/O Lt. Sitaram Sarnakar of vill. Bhalkuriya, PS Para, Dist. Purulia and arrange for its investigation.
