Sub:- Complain for starting a specific case.

Sir,

In producing herewith 01 (One) arrested accused person namely Baneswar Singh Sardar (22 yrs.) S/O Sambhu Nath Sing Sardar of Vill.- Amrakocha, P.O- Chatumadar , P.S-Hura, Dist. -Purulia , driver of tractor No- WB 55A /9269 and seized tractor Mahindra B-275 DI TU MKM DLX (Red Colour) along with trolley without registration number, loaded with sand approx 100 cft. I beg to submit that I, ASI Susanta Mishra along with C/1228 Babulal Hansda, C/1260 Santosh Saren all of Pancha PS were performing Spl. mobile duty vide Pancha PS CC No- 527 /22 Dt. 15.03.22 and at 22:35 hrs received a credible source information that one tractor is coming from Gagda bali Ghat under Pancha PS loaded with sand illegally. Accordingly I intimated the matter to you over phone and as per your direction we were going towards Gagda bali Ghat side to work out the information. But at about 23:45 hrs when we reached near Bhutam more found that above noted tractor was coming from Gagda bali Ghat side towards Baragram more but the vehicle suddenly stopped 30/50 meter away from us and one person from said tractor seems to be the driver of the tractor and started running. We chased to apprehend the person and in spite of hot chase we managed to apprehend the above noted person. On being asked the detained driver, failed to produce any relevant documents in respect of loaded sand as well as failed to produced vehicle related documents.

So, there is reason to believe that the driver of above noted tractor, also registered owner of this tractor have collected the said sand either by theft or by any fraudulent means and after hatching a criminal conspiracy, they were trying to dispose of the same sand in a clandestine manner to Baragram side knowing it to be stolen, as per their regular practice.

Accordingly I seized the Tractor bearing Registration No WB 55A/9269 along with trolley without registration number loaded with sand approx 100 C.F T. under proper seizure list duly signed by witnesses from the possession of arrested above noted accused driver Baneswar Singh Sardar (22 yrs.) S/O Sambhu Nath Singh Sardar of Vill.- Amrakocha, P.O- Chatumadar , P.S-Hura, Dist. -Purulia after maintaining all formalities of Hon'ble Apex Court of India. So, the driver of said tractor and registered owner of the said tractor have committed offence U/S- 379/411/413/414/120B IPC & 21 (1) (4) Mines and Minerals (Development and Regulation) Act-1957.

Under the above fact and circumstances a specific case may kindly be started against driver of Tractor No- WB 55A/9269 namely Baneswar Singh Sardar (22 yrs.) S/O Sambhu Nath Singh Sardar of Vill.- Amrakocha, P.O- Chatumadar, P.S-Hura, Dist. -Purulia and also registered owner of the said tractor U/S- 379/411/413/414/120B IPC & 21 (1) (4) Mines and Minerals (Development and Regulation) Act-1957 and arrange for its investigation.
