Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one accd. person namely Manik Sing Patar (32yrs) S/O- Lt. Kiriti Sing Patar of Vill- Koira PS-Puncha, District- Purulia with seizure of 14 Ltr ID liquor containing one white colour Jericane which were seized under proper seizure list & labeled. I beg to submit that today (17.03.22) at 19:05 hrs while myself along with 1) C/1325- Sunil Kr.Mahato , 2) C/617 Mrityunjoy Sahana were performing anticrime mobile duty near Koira bridge. During mobile duty received source information that one Manik Sing Patar (32yrs) S/O- Lt. Kiriti Sing Patar of Vill- Koira PS-Puncha, District- Purulia has illegally stocked ID liquor in his house of vill- Koira under PS- Puncha & selling the same. On receiving this information, I informed the matter to you and as per your instruction myself along with force proceed to the said place to work out the information. at 19:35 hrs after reaching at Koira village held raid in the house of Manik Sing Patar (32yrs) S/O- Lt. Kiriti Sing Patar of Vill-Koira PS-Puncha, District-Purulia and found that the above noted person was keeping / selling ID liquor which were kept in his house in white colour Jericane. On being asked he gave different statement in different time. on demand Manik Sing Patar failed to produce any valid document in respect of keeping/selling of ID liquor. As such he committed offence u/s 46 A(c) B.E. Act 1909. So on today (17.03.22) in between 19.45 to 20.05 hrs I seized one white colour plastic Jericane containing 14 Ltr ID liquor in this Jericane under proper seizure list duly signed by him and witnesses and labeled and out of which one ltrs of ID liquor is taken as sample which is sealed and labeled in a plastic bottle. On today (17.03.22) at 20.10 hrs I arrested him U/S-67BE Act During arrest the ground of arrest was duly notified, issued arrest memo u/s 50 Cr. P.C. and handed a copy of the same to arrestee. I also issued check list U/S-41 (1)(a), (b) (I), (II) Cr.P.C. Direction of the Supreme Court of India vide Criminal Appeal No.-1277 of 2014, Spl. Leave petition.

Under the above facts and circumstances I therefore pray that a specific case may kindly be started against The arrested accd. Manik Sing Patar (32yrs) S/O- Lt. Kiriti Sing Patar of Vill-Koira PS-Puncha, District-Purulia under proper section of law.
