Sub:- Complaint for starting a specific case.

Sir,

In producing herewith 01 (One) arrested accused person namely Manoj Murmu (19yrs), S/O- Mangal Murmu of Vill- Gangardih, P.S- Pucha, Dist- Purulia, driver of tractor No- WB 55B/2431 and seized tractor having Reg. No- WB 55B/2431 model as POWERTRAC 493 PLUS (Blue Colour) along with trolley without registration number. loaded with sand approx 100 Cft. I beg to submit that, I ASI Susanta Mishra along with C/1228 Babulal Hansda, C 749 Jaladhar Kaibarta all of Pucha PS were performing day mobile duty at Rasudih morh (vide Pucha PS CC No- 559 /2022, Dt. 20.03.2022). At 13:05 hrs I received a credible source information that one tractor loaded with sand illegally is coming towards Kundhurka morh from Napara side under Pucha PS under the guidance of one Biswajit Karmakar of Buglidih, PS-Puncha, Dist- Purulia. Accordingly I intimated the matter to you and as per your direction we left towards Kundhurka Morh to work out the information. At about 13:35 hrs when we reached near Kundhurka Morh and placed Naka checking. Later on found that a tractor was coming from Napara side towards Kundhurka morh but the Tractor suddenly stopped 30/50 meter away from us and one person from said tractor seems to be the driver of the tractor and started running. We chased to apprehend the person and after hot chase we managed to apprehend the above noted person. On being asked the detained person disclose his identity as Manoj Murmu (19yrs.), S/O- Mangal Murmu of Vill- Gangardih, P.S-Puncha, Dist-Purulia as driver of tractor having Reg. No- WB 55B/2431 and he failed to produce any relevant documents in respect of loaded sand as well as failed to produce any vehicle related documents along with his driving license. Accordingly I arrested driver Manoj Murmu (19yrs), S/O- Mangal Murmu of Vill- Gangardih, P.S-Puncha, Dist- Purulia after maintaining all formalities as per law. After that I seized the apprehended Tractor bearing Registration No WB 55B/2431 along with trolley without registration number loaded with sand (approx 100 C.ft) under proper seizure list from the possession of arrested accused driver Manoj Murmu (19yrs), S/O- Mangal Murmu of Vill- Gangardih, P.S-Puncha, Dist- Purulia duly signed by witnesses, after maintaining all formalities of Hon'ble Apex Court of India. After that I interrogated the said arrested accused driver of tractor No- WB55B/2431 namely Monoj Murmu. During interrogation he confessed his guilt and it also confessed that as per direction of one Biswajit Karmakar, S/O- Lt. Bhramar Karmakar of Buglidih, PS- Puncha, Dist- Purulia lifted the said sand illegally and dispose the same at Gopalpur side.

So, there is every reason to believe that the driver of above noted tractor, registered owner of this tractor and Biswajit Karmakar of Buglidih, PS-Puncha, Dist- Purulia have collected the said sand either by theft or by any fraudulent means and after hatching a criminal conspiracy, they were trying to dispose off the same sand in a clandestine manner to Gopalpur side knowing it to be stolen, as per their regular practice.

So, the driver of said tractor, registered owner of the said tractor and Biswajit Karmakar of Buglidih, PS-Puncha, Dist- Purulia have committed offence U/S- 379/411/413/414/120B IPC & 21(1)(4) Mines and Minerals (Development and Regulation) Act-1957.

Under the above fact and circumstances a specific case may kindly be started against driver of Tractor No- WB 55B /2431 namely Manoj Murmu (19yrs), S/O- Mangal Murmu of Vill- Gangardih, P.S- Puncha, Dist- Purulia and Biswajit Karmakar, S/O- Lt Bhramar Karmakar of Buglidih, PS-Puncha, Dist- Purulia and registered owner of the said tractor U/S- 379/411/413/414/120B IPC & 21 (1) (4) Mines and Minerals (Development and Regulation) Act-1957 and arrange for its investigation.
