Sub-F.I.R against Sri Laltu Bouri ,S/O-Late Bhajulal Bouri, Village-Bikramdih(Loto),P.O.-Polmi,Pin-723131,Dist-Purulia for unauthorisedly drawal of electricity through direct hooking from nearest LTOH line of WBSEDCL at his premises.

Dear Sir,

I do hereby lodge written complaint empowered by enabling the electricity act 2003 subsequently amendment act-2007 to the effect that Sri Laltu Bouri ,S/O-Late Bhajulal Bouri,Vill-Bikramdih(Loto),P.O-Polmi,Pin-723131,P.S-Punchha,Dist-Purulia has committed theft of electricity under section-135(1)(a) of the electricity act subsequently amendment act-2007 on 24-03-2022 at about 1:20P.M.

I Sri Saikat Mallick,S/O-Himadri Mallick,A.E & S.M of Puncha CCC alongwith 1) Sri Somnath Soren(J.E Gr-I) under puncha CCC ,S/O-Lt. Pannalal Soren 2)Sri Sandip Mahato(O.E) under Puncha CCC,S/O-Lt. Brindaban Mahato, and all the other staff attached to Puncha CCC entered the premises of Sri Laltu Bouri,Vill-Bikramdih(Loto),PO-Polmi,Pin-723131,Dist-Purulia at about 1:20PM and inspected his premises.During the inspection theft of electricity was detected by the way of direct hooking from nearest LTOH line of WBSEDCL under section 135 clause 1(a).

The accused person was consuming electricity dishonestly at his domestic premises by the way of direct hooking from nearest LTOH line causing considerable revenue loss of WBSEDCL ,During inspection total load found was 0.2KW.From the above hooking arrangement he uses the following electrical equipment

- 1) light Bulb-03nos(40 Watt each)
- 2) Fan-01 no(80 Watt)

The following items were seized from the house of the accused person

- 1) 2 core pvc cable(approx length 10 Meter)

Seizure list was prepared at the site and the accused person refused to sign.The inspection team left the premises at about 1:35P.M on 24.03.2022.The accused person has committed an offence U/S 135(1)(a) of E.A-2003 subsequently amendment act-2007.You are requested to take cognizance of this complaint and treat it as F.I.R and action may be taken as per rule.
