Respected Sir,

Today (23.03.2022) during my day mobile duty at 07.35 hrs after being informed by duty officer of Puncha PS regarding road blocked at Pairachali market on Manbazar-Bankura road (SH-4) and the road was obstructed by some villagers of Pairachali village over the issue of demand of permanent posting of Doctor at Pairachali PHC and supply house to house drinking water at Pairachali village, under the leadership of Sailen Mishra and his wife Smt. Binapani Mishra the two specific alleged person of that village regarding their illegal activities. Immediately after receiving the information myself along with force (i) C/1412 Susanta Patra (ii) C/580 Pradip Kr. Bag, (iii) LC/243 Monimala Tudu, (iv) LC/354 Kalyani Tudu, all of Puncha PS vide C.C. No- 573/22 and GDE No -994, Dt. 23.03.22 rushed to the spot at about 08.05 hrs and found that the road has been blocked by the rabble of (i) Sailen Mishra, S/O- Lt. Badal Mishra (ii) Smt. Binapani Mishra, W/O- Sailen Mishra (iii) Laden Das, S/O- Gunjira Das (iv) Mihir Das, S/O- Laxman Das (v) Bharat Pandit, S/O- Lt. Ratan Pandit (vi) Smt. Bedana Dey, W/O- Banshidhar Dey (vii) Smt. Sibani Dey, W/O- Subal Dey (viii) Smt. Sabubala Pandit, W/O-Ramanath Pandit (ix) Smt. Uttara Majhi, W/O- Joydev Majhi all of Pairachali village, PS-Puncha, Dist- Purulia and 09-10 others. After forming unlawful assembly subsequently vehicular traffic was totally disrupted and seized along the Pairachali-Bankura road. I requested the above noted leaders to with draw the blocked but they paid no heed to my words and they demanded for the immediate presence BDO, Manbazar-I to sort out their demand. Despite of all, I persuaded further and tried to convince the agitators that the road is one of the busy public lines of navigation of this district which should not be blocked but they denied my proposal and deter my duty. I along with force started to disperse them form the road but the road blockers obstructed them adamantly from the discharge of their public functions. After the prolonged discussion the mob withdrew the blocked at 08.45 hrs. Thereafter, the vehicular traffic movement became normal after our assiduous act. As the above noted alleged persons along with 9-10 others committed offence u/s 188/186/283 IPC &18 W.B Highway act 1964 under the leadership of Sailen Mishra and his wife Smt. Binapani Mishra. So a specific case may kindly be initiated against them and arranged for its investigation.
