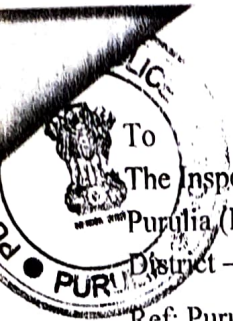

Sir,

In producing herewith one arrested accd. person namely Sudarshan Mondal (38 yrs) S/O Anath Bandhu Mondal of Vill- Kashmar, PO-Chakadoba, PS- Belpahari, Dist- Jhargram, A/P wine Bhati of Md.Parvez Alam, Raghampur behind Moti Hotel, PS-Tamna, Dist-Purulia with seizure list and seized articles.

I beg to submit that today (29.03.2022) while I was detailed to perform mobile duty in PS area along with force (i) C/624 Pradip Chakraborty , (ii) NVF/0068 Mahanta Mahato & (iii) NVF/969 Pralay Mahato all of Purulia (M) PS & Purulia (M) PS GDE No 1305 Dtd. 29.03.2022. During my sudden Naka checking at Nadiara village more as per order of I/C Purulia (M) PS detained one person carrying country sprite (Dil Khush). During interrogation he did not produce any valid documents in r/o carrying country sprite. On asking the identity he disclosed his name address as noted supra. On interrogation he confessed that he selling illegally the country sprite (Dil Khush) among Nadiara villagers and adjacent area so that he could gain more amount from the selling of (liquors) Country Spirit. Subsequently, I seized 17 (seventeen) sealed bottles country sprite (Dil Khush) each containing 600 ml. In which kept 01 sealed bottles as sample. I seized the same under proper seizure list in presence of witnesses and duly signed by witnesses and accused person. Consequently, I arrested the above noted accused person after informing him the ground of arrest and issued Memo of Arrest and observed all legal formalities in respect of the Arrest. The seized articles were properly sealed and labeled in presence of witnesses duly signed by them and accused person.

The above noted arrested person namely Sudarshan Mondal (38 yrs) S/O Anath Bandhu Mondal of Vill- Kashmar, PO-Chakadoba, PS- Belpahari, Dist- Jhargram, A/P wine Bhati of Md.Parvez Alam, Raghampur behind Moti Hotel, PS-Tamna, Dist-Purulia committed offence U/S 46 A (c) of Bengal Excise Act. 1909 for unauthorized possession for selling of Country Spirit from his house. Under the fact and circumstance kindly take necessary lawful action against Sudarshan Mondal (38 yrs) S/O Anath Bandhu Mondal of Vill- Kashmar, PO-Chakadoba, PS- Belpahari, Dist- Jhargram, A/P wine Bhati of Md.Parvez Alam, Raghampur behind Moti Hotel, PS-Tamna, Dist-Purulia.
