I beg to submit that today (29.03.2022) while I was detailed to perform mobile duty in PS area along with force (i) C/624 Pradip Chakraborty, (ii) NVF/0068 Mahanta Mahato & (iii) NVF/ 969 Pralay Mahato all of Purulia (M) PS & Purulia (M) PS GDE No 1305 Dtd. 29.03.2022. During my sudden Naka checking at Nadiara village more as per order of I/C Purulia (M) PS detained one person carrying country sprite (Dil Khush). During interrogation he did not produce any valid documents in r/o carrying country sprite. On asking the identity he disclosed his name address as noted supra. On interrogation he confessed that he selling illegally the country sprite (Dil Khush) among Nadiara villagers and adjacent area so that he could gain more amount from the selling of (liquors) Country Spirit.
