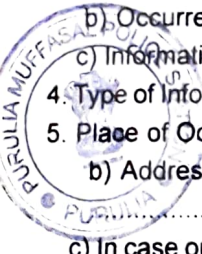

Sub :- First Information Report.

Respected Sir,

I, AMIT KUMAR MAHTO⁽¹⁹⁾, S/o. Late Benarasi Mahto, resident of Village. - Jagdishpur, P.O.- Risaura, P.S.- Mharajganj, Dist.- Siwan hereby inform you, that on 15/02/2022 at about 8:45 pm when my father Benarasi Mahto, son of Late Sudama Mahato, aged about 40 years, was going by foot to wards, Ranchi Road, from Purulia, through Chas Road and when he reached near Chakra Village suddenly one Motor Cycle Vide No. WB40AL / 1343 came at a very high speed from his back side in a very rash and negligent manner and dashed my father, as an impact my father sustained severe injuries all over his body and had bleeding injuries. Immediately he was taken to Purulia Sadar Hospital, and as a serious case he was taken to Bankura Medical College where he succumbed to his injuries after some time.

Post Mortem done by the M O of said Hospital on 16/02/2022. That the accident occurred due to rash and negligent driving of the rider of the Motor Cycle Vide No. WB40AL / 1343. One UD Case has been started under Bankura PS vide UD Case No. 91/2022 dated 16.02.2022

Due to sudden death of my father we had such a mental shock and agony, we could, not file the written complaint before the police on time, so this delay can be pardoned.
