Sir,

In producing herewith one arrested accused person namely Alock Bauri @ Ajay (40) S/o Lt. Sarat Bauri of Vill.+PO - Sanka, PS - Raghunathpur, Dist.- Purulia under arrest along with seized articles as per seizer list i.e. 33 (Thirty Three) bottles Country Sprit styled as 'Dilse' measuring 600 ml each and (2) 15 (Fifteen) bottles Country Sprit styled as 'Captain' measuring 600 ml each kept in a white plastic bag under proper seizure with label.

I SI Swapan Majumdar of Raghunathpur PS hereby lodged a written complaint against the above noted accused person to the effect that on 23.03.2022 during my evening mobile duty I received a credible source information that the above noted accused person was selling country sprit illegally in the house of the above noted accused at Sanka village under this PS. On receipt such information I immediately informed the matter to IC of the PS and as per his direction I along with force left to work out the information (This refers to Raghunathpur PS CC No. 779/22 dated 23/03/2022). At 18:15 hrs we reached at Sanka village and my source shown the person from a distance who was selling the liquors. We immediately reached there and surrounded him, but other people who were assembled there to purchase liquor, on seeing Police Party managed to flee away from the spot and found the huge quantity of country sprit "Dilse" & "Captain" bottles were kept there in concealing condition. On searched 33 (Thirty Three) bottles Country Sprit styled as 'Dilse' measuring 600 ml each and (2) 15 (Fifteen) bottles Country Sprit styled as 'Captain' measuring 600 ml each kept in a white plastic bag was found there. On demand he failed to produce any license / authority of the said liquors. On interrogation he also made incoherent statement regarding possession of said liquors and told that he is usually selling the same to the villagers/pedestrian illegally. So, finding no any other alternative way I seized the above noted articles from the possession of the accused person and labeled, duly singed by the accused person & witnesses in between 18:35 hrs to 18:55 hrs in which 01 (One) bottle of "Dilse" measuring 600 ml and 01 (One) bottle of "Captain" measuring 600 ml was kept as sample file with label. During interrogation he confessed his guilt as such I arrested him at 19:05 hrs after observing all the formalities as per law issuing memo of arrest as the accused person is liable for prosecution w/s-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused person namely Alock Bauri @ Ajay (40) S/o Lt. Sarat Bauri of Vill.+PO - Sanka, PS - Raghunathpur, Dist.- Purulia u/s-46A (c) of the Bengal Excise Act 1909.
