In producing herewith one seized vehicle i.e. Tractor SWaRaJ 735 FE bearing Reg. Number-WB 68Z 0238, & having Chassis No- WZTG30428132754 fitted with Trolley loaded with sand. The fact of the case in brief is that on 28/02/2022 I, PSI Mrinmay Bhakta of Santuri P.S along with force were on mobile duty. During mobile duty on 28/02/2022 at about 17:15 hrs received credible source information that one Tractor is coming from Mohanpur Village side under Santuri PS loaded with sand. After receiving this information we were proceeding towards Mohanpur Village to work out the information. When we reached near Mohanpur Village, found that one Tractor is coming from Mohanpur Village side loaded with sand (Approx. 100 cft). On seeing the Police party the driver was trying to flee away. Number-WB 68Z 0238, & having Chassis No- WZTG30428132754 fitted with Trolley with ill motive are transporting sand illegally without any valid document in support of carrying sand. So they are liable for offence punishable U/S 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against the driver and owner of Tractor SWaRaJ 735 FE bearing Reg. Number-WB 68Z 0238, & having Chassis No- WZTG30428132754 fitted with Trolley may kindly be started and arrange for its investigation.
