Sub:- Prayer for lodge F.I.R
Sir,

I, Shri Sekhar K.r Mitra , Inspr. of Police, DEB Purulia do here by lodged a complaint against one Narugopal Ghosh (48) S/O Lt. Dukhit Ghosh of vill- Matidundra P.O-Garshikha , P.S-Santuri Dist-Purulia along with following seized articles viz

- 1) 01 quintal boiled Rice containing in 02 plastic packets in sealed condion
- 2) 07 quintal 50 kg Wheat containing in 15 plastic packets
- 3) 450 kg Wheat containing in 09 plastic packets without sealed
- 4) 01 Electronic weighing machine S/L no-U/10018, class-III,voltage-220
- 5) 703 kg Atta containing 740 sealed plastic packets, per packet weight 950 gms

which are all packets contained in 14 plastic Basta to the effect that today on 23/03/22 on the basis of secret and credible information I, Shri Sekhar Kr. Mitra, Inspr. of Police, DEB Purulia along with ASI Swapan Chakraborty , C/88 Pradut Kumar Mondal, HG/1427 Benimadhab Char had been to the Santuri PS and submit a requisition to O/C Santuri PS for rendering assistance and noted the credible information at Santuri PS at 10:45 hrs vide Santuri PS GDE no. 799 dated 23/03/22. Thereafter, ASI Madhu Mangal Bauri and force of Santuri PS and myself along with my team of DEB Purulia left for Bhagabandh under Santuri PS to work out the information by availing Govt. vehicle bearing No. WB 24AJ/0930 . On arrival at Bhagabandh to work out the information one local people viz (1) Budheswar Buskey S/O Lt. Nanku Buskey of TaraBari , PS-Santuri, & (2) Rabilal Kisku S/O- Nandalal Kisku Vill- Lapahari P.S-Santuri both of Dist-Purulia to assist us for holding raid, search and seizure in the shop of Narugopal Ghosh (48) S/O Lt. Dukhit Ghosh of vill- Matidundra P.O-Garshikha , P.S-Santuri Dist-Purulia. Thereafter myself along with accompanied officers and force and with the active assistance of above noted two local witnesses held raid in the shop of Narugopal Ghosh after observing all formalities as laid down in Section 100 of Cr.PC 1973 relating to search & seizure. Prior to hold raid in the shop we noticed huge number of Rice, PDS Atta and wheat staged inside the room of shop along with apparatus which is used for illegal selling. The shop owner namely Narugopal Ghosh asked to produced valid documents / license for running his business in respect of possessing Rice, PDS Atta and wheat but the shop owner failed to produce any valid documents/ license for running such illegal business. As such I seized the articles as mentioned above and in the seizure list in presence of local witnesses and Police witnesses under proper seizure list from the shop of Narugopal Ghosh.

As Narugopal Ghosh failed to produce any valid documents/ license for running such business, hence he violated provisions laid down in Para 7 of rule 3 of West Bengal. Thus he committed an offence punishable U/S- 7 (1)(a)(ii) of E.C (X) of Act 1955 against owner Narugopal Ghosh accordingly

In course of local enquiry it revealed that said Narugopal Ghosh is running clandestine business of PDS goods since long without having any authority or license and only for causing his wrongful gain and deprived poor local consumers/customers as well as causing loss of revenue to the Govt.

I therefore request you to start a case U/S 7 (1)(a)(ii) of E.C (X) of Act 1955 against Narugopal Ghosh (48) S/O Lt. Dukhit Ghosh of vill-Matidundra P.O- Garshikha , P.S-Santuri Dist-Purulia


The above seized PDS Rice, Atta, Wheat as mentioned in seizure list Sl. No. 1, 2,3,5 left in zimma to one MR Distributor; Authorize Manager namely Manaranjan Chanda S/O Lt. Manik Lal Chanda of Vill- Raghunathpur, Tantipara PS- Raghunathpur , Dist- Purulia vide Licence No- PUR-RGH-274, after taking proper zimmanama in anticipation of kind approval of the Ld. Court Raghunathpur . Seized articles Sl. No. 4 kept in PS Malkhana of Santuri PS.

As per kind direction of S.P DEB Purulia the case will investigate ASI Prabir Kr. Mukharjee of DEB, Purulia.
