
In producing here with one arrested accused namely Amit Singh (40 Yrs) S/O Kista Singh of 5 No near Ghora Park Adra, PS-Adra, Dist-Purulia along with following seized articles with seizure list and Memo of Arrest.

- 1) 15 bottles DIL KHUSH country spirit, 600 Ml. each Rs/-50 of each bottle.

I SI Satrughna Mahato of Adra PS do here by lodged a complaint against accused namely Amit Singh S/O Kista Singh of 5 No near Ghora Park Adra, PS-Adra, Dist-Purulia to the effect that today (17/03/2022) in course of evening patrolling duty as per order vide Adra PS CC No-1161/22 dtd.17.03.22. I received a information from a reliable source at about 18:25 hrs that one Amit Singh is selling country spirit illegally at his jhupri in front of Account office Adra. After getting such information I informed to I/C Adra P.S over telephone and as per his direction I along with accompanied force reached at jhupri in front of Account office Adra at about 18:45 hrs and held raid at jhupri in front of Account office Adra and found that the above noted accd. Person selling country spirit at his Jhupri and after seeing the Police party, all the person fled away and said Amit Singh has tried to conceal himself but we able to apprehend him. I asked him to produced valid License or valid papers in respect of selling of country spirit but he failed to produce any valid license or documents in respect possessing /selling the same. So it is sufficient reason to believe that above said Amit Singh engaged to sale the country spirit by illegal way. So I seized the above mentioned country spirit under proper seizure list duly sign by accused person and available witnesses. I also collect sample from seized country spirit duly sealed and labeled by me. There after I arrest the above mentioned accused person with informing him the ground of arrest. The complete process was done in between 18.45 hrs to 19.25hrs.

I there for pray that a specific case may kindly be start against arrested accused Amit Singh (40 Yrs) S/O Kista Singh of 5 No near Ghora Park Adra, PS-Adra, Dist-Purulia under proper section of law.
