In producing herewith arrested accused persons namely 1) Mahesh Yadav (32 Yrs) S/O Kisun Yadav of Vill-Shivpur, PS-Barrah, Dist- Arrah, Bhojpur (Bihar) driver of the Vehicle No- WB19K/9741 (2) Dharmendra Singh (37 Yrs) S/O Biswamitra Singh of Vill-Durlav Pur, PS-Simri, Dist-Buxar (Bihar) Khalasi of the Vehicle No- WB19K/9741 along with seizure list as seized articles (1) 05 number of different colors Cows (2) 03 number of different colors Cows Calf (3) 03 number of Black colors Buffalo (4) 01 Number of black colors Buffalo Calf (5) One white color TATA Turbo Truck vide Reg. No- WB19K/9741.

I, SI Simanta Tantubai of Adra PS lodged a written complaint to the effect that today i.e. 02/04/2022 while I along with force performing evening mobile duty vide Adra PS CC No-1306/22 and GDE No. 63 dtd. 02/04/2022 got a source information regarding transportation of cattle for the purpose of smuggling. Accordingly I inform to I/C Adra PS about the matter and as per his direction I along with C/140 Subrata Banerjee and HG/1845 Matru Hembrom both of Adra PS left for Gosaindanga Village More to pursue the source information by govt. vehicle. I along with force reached at Gosaindanga Village More and as identified by source started proceeding towards the shadow corner of a tree and kept close watch. Then we saw the above noted persons coming from Raghunathpur side with cattle's and Buffalo by vehicle vide Reg. No-WB19K/9741 at about 14:35 hrs. We immediately apprehended them with 12 number of different colors cattle's which were taken in that vehicle with very unsafe and painful condition to the animals binding them with a rope covered by a plastic sheet. On being asked they disclosed their identity as noted above. I asked them to produce any valid documents in the support of said cattle's and Buffalo but they unable to produce any valid documents. So, I suspected that the cattle's and Buffalo were said to be stolen property and were carrying for the purpose of smuggling and they also violated the provisions of prevention of cruelty of animal act. On interrogation they confessed that the said cattle's and Buffalo were transporting for the purpose of smuggling to Baruiipur Howrah. After that I seized the (1) 05 number of different colors Cows (2) 03 number of different colors Cows Calf (3) 03 number of Black colors Buffalo (4) 01 Number of black colors Buffalo Calf (5) One white color TATA Turbo Truck vide Reg. No- Reg. No-WB19K/9741 under proper seizure list duly signed by the police witnesses as well as local witnesses. Then, I arrested the above noted accused persons who were indulging in the smuggling and carrying the cattle's and Buffalo to Baruiipur, Howrah.

On interrogation they also confessed that they are engage in smuggle the cattle by the order of another person namely Yodha Singh of Bihar. After wards the seized cattle were kept zimma of one Mannu Yadav S/O Bijender Yadav of Vill-Monipur near Satguru Ashram, PS-Adra, Dist- Purulia for safety and security of the cattle. Zimma Nama is attached herewith.

Under this circumstances I request to you kindly start a case under proper section of law against arrested accused persons 1) Mahesh Yadav (32 Yrs) S/O Kisun Yadav of Vill-Shivpur, PS-Barrah, Dist- Arrah, Bhojpur (Bihar) 2) Dharmendra Singh (37 Yrs) S/O Biswamitra Singh of Vill-Durlav Pur, PS-Simri, Dist-Buxar (Bihar) (3) Yodha Singh of Bihar and the owner of the vehicle bearing Reg. No- WB19K/9741.

Received on 02/04/2022 at 16:15 hrs. and started Adra P.S. Case no 57/2022 & all 02/04/2022 U/S 379/411/414, 420 and read with Section 11(C) (a) (ii) of the Prevention of Cruelty to Animal Act 1960.
