In producing herewith arrested accused person namely Sagar Sen (26 yrs) S/O Ashok Kumar Sen of Bedia Para, Ward No-07, P.S- Raghunathpur, Dist- Purulia along with seized articles (1) One Red colour Hero Honda Super Splendor Motor Cycle vide Reg. no- WB-56F-5009.

I beg to report that today myself along with C/424 Naba Kumar Shaw, C/568 Madhusudan Rajowar were engage in Night Mobile duty performing NAKA duty at Adra-Raghunathpur Pitch road near Jhankai Seni Kali Mandir under Adra PS, vide Adra PS C.C No-1362/22 dtd.08/04/2022 and Adra PS GDE No-314 at about 22:15 hrs. I found one Red colour Hero Honda Super Splendor Motor Cycle vide Reg. no-WB-56F-5009 coming from Raghunathpur side towards Adra side rashly and negligently. We try to stop him but the rider of the said motorcycle named in above was trying to escape the place so rashly, there was every possibility of loss/ serious injury of nearby public due to his such riding. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life.

So, I arrested him as he violated sec 279 IPC and 184 MV Act 1988 at about 22:35 hrs. I also seized the motor cycle with a view to prosecute him U/S 279 IPC and 184 MV Act 1988 in presence of police party. As the place is lonely so there is no public present at that time. The whole process of seizure was completed in between 22:15 hrs to 22:35 hrs. His family member was also informed about the ground of arrest.

Hence I pray that a specific case U/S 279 IPC and 184 MV Act 1988 may kindly be initiated against accused Sagar Sen (26 yrs) S/O Ashok Kumar Sen of Bedia Para, Ward No-07, P.S- Raghunathpur, Dist- Purulia.
