Sir.

In producing herewith accused Nunaram @ Nuna Gorai (31Yrs), S/O- Dulal Gorai of vill-Herodih, PS- Arsha, Dist- Purulia, with one improvised country made fire arms, I ASI Nivas Ch. Mahato beg to state that on 02/04/2022 at 18.55 hrs, I received a source information through my cell phone that one person is moving aimlessly and suspiciously at Hensla more under Arsha PS area. His movement was very much suspicious in nature.

Receiving such information, diarized the fact in G.D vide GDE No. 63 Dtd. 02.04.2022. I informed O/C over phone and as per direction of O/C Arsha PS myself along with force i.e. (i) C/1516 Arnab Sinha (ii) C/17 Tapas Kr. Meta (iii) C/22 Dhiren Murmu (iv) C/345 Sourav Choudhury all of Arsha PS, Dist-Purulia vide C.C. No. 717/22 dtd 02.04.2022 left PS and started for Hensla more. At about 19.35 hrs with Bolero Vehicle bearing No WB 55C/9389 reached Hensla more and as per identification of my source myself along with force got down from the vehicle at about 19.40 hrs. Seeing us, the above accused attempted to run away but could not succeed. I got hold of his hand and other two accompanied force cordoned him. After detaining him I asked him about his details, purpose of moving there. Firstly he was not revealing the truth but later on repeated questions, he revealed his identity as noted above. I informed him that he would be searched by us and offered him to search our person before our search. Finding no other option, we searched him and from his back side of waist, inside the back portion of his pant (1) One improvised country made fire arms made of iron having length of 26.5 cm from the end point of butt to that of the barrel, length of butt is 13.5 cm approx, barrel 13 cm approx, having trigger and firing pin, etc. On demand he was unable to produce any valid documents /license in respect of keeping such arms, neither he can gave any satisfactory explanation in respect of carrying such arms. It appeared that he possessed those either to sell or to commit any crime. So I seized the said arms with proper seizure list and the seized arms packed, sealed and labelled in presence of police witnesses since none found there available to witness the seizure in between 19.55 hrs and 20.25 hrs. Hence I arrested him at about 20.35 hrs observing all guideline of NHRC and Honble Apex Court regarding arrest, as he has committed an offence which is punishable U/S -25(1)(a)/27 of Arms Act.

Hence I along with force returned to PS and submitted a complainant against accused Nunaram @ Nuna Gorai (31Yrs), S/O- Dulal Gorai of vill- Herodih, PS- Arsha, Dist- Purulia to start a specific case under proper section of law.
