No. 148/22 dtd. 04.04.2022 and GDE No. 128 Dtd. 04.04.2022 Reaching at Beldih village at about 13.55 hrs we fixed-up in the house of above noted accd. person and found that selling of Id Liquor was going on there and having seen police all customers managed to escape, but we were able to apprehended the above noted accused person. On demand of showing papers he failed to produce any valid documents in support of selling ID liquor. So I seized all the implicating articles as noted above under a proper seizure list from his exclusive possession in presence of witnesses and properly sealed and labeled duly signed by the accused person and witnesses among which approx 500 ml taken out from the above container as sample packed with sealing wax with label. During interrogation he confessed his guilt. So, I arrested him after observing all the formalities issuing memo of arrest as he was selling ID liquor illegally.

I therefore pray that a specific case may kindly be started against the accused person namely Josthi Mudi @ Harkhu Mudi (40 yrs) S/O Lt. Lakhiram Mudi of vill Beldih, P.S.-Arsha Dist-Purulia under proper section of law.
