Sir,

I, ASI Janardan Kumar of Arsha PS in producing herewith one country made iron fire arms under proper seizure list duly signed by the seizure witnesses. I would like to inform you that today i.e. 04/04/2022 at about 19.25 hrs. while myself accompanied with 1) C/238 Dipak Bagti of Arsha PS and 2) C/333 Sitaram Mahato of SAP 7th BN camp at Arsha PS along with Govt. vehicle bearing Reg. No. WB56C-9389 were engaged in anticrime day mobile duty at the Arsha PS area (Vide Arsha PS C.C. No. 724/22 dtd. 04/04/2022 and Arsha PS GDE No. 118 dtd. 04/04/2022) received an information from my secret source that an unknown miscreant is present near Kourang Jungle with a firearms. I informed the fact to O/C Arsha PS over cell phone (Vide Arsha PS GDE No. 146 dtd. 04/04/2022) and as per order of O/C Arsha PS myself along with force left for spot. Having reached near the spot at about 19.45 hrs, kept our vehicle in a distance and we the police party crawled towards the spot with my source. In the light of vehicle found that one person is sitting on the rostrum of a big tree and one object is just right side of him on which that person was keeping his right hand. When we reached very close to him, hearing our footstep, that person became alert and seeing us and started to flee away. We chased him, but he disappeared at dark. Returning to the spot and found one firearms like object. During thorough search with the help of torch light, observed that the object is one improvised country made fire arms. I tried to get public witnesses there, but none could be availed. So, I seized the said improvised country made fire arms with the help of my accompanying force and labelled also.

Under the above fact and circumstances, I therefore lodged this typed complaint against the unknown miscreant for taking necessary further step under proper section of law.
