

Sir,

In producing herewith accused Shibu Majhi (42Yrs), S/O- Durjadhan Majhi of vill- Satra, PS- Arsha, Dist- Purulia, with one improvised country made fire arms with 02(two) .303 live ammunitions, I ASI Rajib Chakraborty beg to state that on 08/04/2022 at 17.05 hrs, I received a source information through my cell phone that one person is moving aimlessly and suspiciously at Mishirdih more under Arsha PS area. His movement was very much suspicious in nature.

Receiving such information, diarized the fact in G.D vide GDE No. 251 Dtd. 08.04.2022. I informed O/C and as per direction of O/C Arsha PS myself along with force i.e. (i) C/15 Sushanta Dey (ii) C/1516 Arnab Sinha both of Arsha PS and (iii) C/1002 Arif Mohammad and (iv) C/971 Amit Manna of SAP 7th BN camp at Arsha PS, Dist-Purulia vide C.C. No. 764/22 dtd 08.04.2022 left PS and started for Mishirdih more. At about 17.35 hrs with Govt. bearing No WB 55C/9389 reached Mishirdih more and as per identification of my source myself along with force got down from the vehicle at about 17.55 hrs. Seeing us, the above accused attempted to run away but could not succeed. I got hold of his hand and other accompanied force cordoned him. After detaining him I asked him about his details, purpose of moving there. Firstly he was not revealing the truth but later on repeated questions, he revealed his identity as noted above. I informed him that he would be searched by us and offered him to search our person before our search. Finding no other option, we searched him and from his back side of waist, inside the back portion of his pant (1) One improvised country made fire arms made of iron having length of 26 cm from the end point of butt to that of the barrel, length of butt is 09 cm approx, barrel 17 cm approx, having trigger and firing pin etc and from left side pocket of his pant recovered 02 (two) nos. of .303 live ammunitions. On demand he was unable to produce any valid documents /license in respect of keeping such arms and ammunition, neither he can gave any satisfactory explanation in respect of carrying such arms and ammunition. It appeared that he possessed those either to sell or to commit any crime. So I seized the said arms and ammunition with proper seizure list and the seized arms & ammunition packed, sealed and labelled in presence of police witnesses since none found there available to witness the seizure in between 18.25 hrs and 18.45 hrs. Hence I arrested him at about 18.55 hrs observing all guideline of NHRC and Honble Apex Court regarding arrest, as he has committed an offence which is punishable U/S - 25(1)(a) of Arms Act.

Hence I along with force returned to PS and submitted a complainant against accused Shibu Majhi (42Yrs), S/O- Durjadhan Majhi of vill- Satra, PS- Arsha, Dist- Purulia to start a specific case under proper section of law.
