Sub: To lodge FIR against owner and driver of One Mahindra tractor having Reg. No. WB-55A/9849 along with trolley (sand approx 60 CFT)

Sir,

In producing herewith, 01 Mahindra tractor without having Reg. No. WB-55A/9849 along with trolley (approx 60 CFT trolley). Today on 26.04.22 on Spl. Mobile duty at PS area vide CC No. 870/22 Dtd. 26.04.22 I, PSI Avijit Mondal along with (i) C/-694 Nekibuddin Khan and (ii) C/- 853 Kiran Ch. Murmu both of Arsha we reached at River Kansai near Rangamati village under Arsha PS at 16.35 hrs, we conducted raid on the Bank of River Kansai under Arsha PS raid at the found 01(one) tractor along with trolley attached with a hinge was present at Rangamati sand ghat on the bank of River Kansai. Some persons were loading sand in the attached trolley of said tractor. Seeing the Police party, those persons leaving the tractor (loaded with sand in the attached trolley) at Rangamati ghat, fled away. Police rushed to the tractor and detained the said tractor. Police searched the said tractor and found that the tractor is loaded with sand and also searched surrounding but could not trace out the person & driver of said offending tractor. Hence, I seized the above noted tractor along with trolley and brought the tractors to Arsha PS. As there is every reason to believe that the driver and owner of the said tractor with ill motive were transporting sand illegally without any valid document in support of carrying sand and violating the Govt. order they are doing such illegal activity.

Hence, I do hereby lodge this complaint against the owner and driver of above noted tractor vide along with the trolleys and unknown others for investigation.
