Sir,

In producing herewith the accused Dipankar Kumar @ Akal (28 Yrs), S/O-Basanta Kumar of Vill-Saragdih, P.S-Baghmundi, Dist-Purulia, before you and with one country made iron made improvised fire arms having 9.5 inch length (Approx) iron Butt, hody, firing pin and triggered as working condition with one live cartridge of length 3 inch (Approx) sealed and labeled which were seized from his possession. I, SI Sudhir Kumar Mahato of Bagmundi PS beg to state that Today (02.04.2022) during my special evening mobile duty vide GDE No-81, Dtd: 02.04.2022 and CC No-665/2022 received secret source information that the above noted person possessed a "Saman" (a improvised pipe gun) with him and was wondering at Link Road area under Baghmundi PS. After receiving this information I informed the matter to you as well as the duty officer and as per your direction myself along with C/1303 Biswanath Majhi and C/05 Biswajit Mahapatra proceeded for the place to execute the information with Govt. vehicle.

At about 21.35 hrs we reached near Link Road, Baghmundi and I met with my source there who corroborated his information again. Afterwards we proceeded towards the described spot. On the way I tried to find local people but nobody present there. As we reached there we found one person is trying to flee away but we managed to apprehend the person. On being asked he disclosed himself as Dipankar Kumar @ Akal (28 Yrs), S/O-Basanta Kumar of Vill-Saragdih, P.S-Baghmundi, Dist-Purulia. After apprehension we disclosed our identity to him and the purpose of his apprehension and on being asked he disclosed his name and address as noted above and also stated that he was present there for some time being equipped with fire arms loaded with ammunition for committing a crime at the said area. Then at first I requested him to search our persons and he refused, after that I searched the said person in presence of the witnesses. On being searched I recovered the above noted articles from his possession kept in the waist of the person and being asked he failed to produce any valid documents or papers in support of the said fire arms. As such I seized the same under proper seizure list and prepared label in presence of witnesses duly signed by them and I supply a copy of seizure list to the apprehended person in between 22.05 hrs and 22.35 hrs and he was arrested for possessing illegal fire arms and he is liable to be prosecuted under provision of Indian Arms Act for illegal possession of fire arms and ammunition. After seizure I arrested the above noted apprehended person with a charge for possessing illegal fire arms after observing all norms of NHRC and Hon'ble Supreme Court of India at 22.35 hrs.

I brought the arrested person to Baghmundi PS and put him to P.S lock up after observing all Hazat formalities, supplied sufficient food and drinking water. I made over the complaint, seizure list as well as arrest memo to the on duty officer of Baghmundi P.S for taking necessary action. I also handed over the seized articles to the Malkhana Officer.

Under the above circumstances I am pray before you to start a specific case under proper section of law against Dipankar Kumar @ Akal (28 Yrs), S/O-Basanta Kumar of Vill-Saragdih, P.S-Baghmundi, Dist-Purulia, and obliged.
