Sir,

In producing herewith the seizure list and the seized articles i.e. one country made iron made improvised fire arms having 8.5 inch length (Approx) having wooden Butt having length 3.6 (Approx) inch and iron made barel having length 4.7 inch (Approx), body, firing pin and triggered as working condition with one live cartridge of length 3 inch (Approx) sealed and labeled. I, SI Asish Mondal, I/C Suisa OP under Baghmundi PS, Dist- Purulia beg to state that today (04.04.2022) during my special evening mobile duty vide Suisa OP GDE No-103, Dtd: 04.04.2022 and Suisa OP CC No-397/2022, dtd-04.04.2022 received secret source information that the unknown person possessed a "Saman" (a improvised pipe gun) with him and is wondering at Tapabon more area under Baghmundi PS. After receiving this information I informed the matter to you as well as the duty officer and as per your direction myself along with C/229 Asit Molla and C/2008 Basudeb Das of Suisa OP under Baghmundi PS, Dist- Purulia proceeded for the place to execute the information with Govt. vehicle.

At about 23.05 hrs we reached near Tapabon more area, Baghmundi and I met with my source there who corroborated his information again. Afterwards we proceeded towards the described spot. On the way I tried to find local people but nobody present there. As we reached there we found one person is trying to flee away seeing us. We chased him but he disappeared in the dark towards Jhalda through Baghmundi-Jhalda main road. At the time of chasing we heard a sound of falling something weighty on the way and also saw that the thing was thrown by the unknown miscreant. On search in presence of accompanied forces found one improvised country-made firearms at Baghmundi Jhalda road side bush area near Tapabon more. As such I seized the same under proper seizure list and prepared label in presence of witnesses duly signed by them in between 23.10 hrs and 23.25 hrs took the help of an investigation kit box, for this purpose. I also sealed the same at said place. I held a local enquiry in and around the P.O. to collect information about the culprits with intent to arrest him, but no fruitful result. I also engaged source to trace out the unknown miscreant.

Then we left for Baghmundi PS to start a specific case and to take further action as per provision of law. The unknown miscreant was carrying a country made pipe gun and ammunition to sell/transfer for illegal purposes and for unlawful gain.

Under the above circumstances I am pray before you to start a specific case under proper section of law against unknown miscreant, and obliged.
