

Most respectfully sheweth:-

- 1) That on 27.11.2021 at about 7.30 A.M. when the complainant after taking groceries was on the way to his house from the grocery shop under the proprietorship of his co-villagers namely Krishna Saw son of Late Hiralal Saw, suddenly one of his another co-villagers Hari Nrayan Singh Babu son of late Rasaraj Singh Babu out of previous grudge inflicted forceful assault with the help of a shovel on the right leg of your petitioner/complainant.
- 2) That resultantly your petitioner then and there failed down on the earth when said Hari Nrayan Singh Babu with an intention to kill the complainant struck a blow aiming at his head but fortunately your petitioner managed to removed his head and said Hari Narayan Singh Babu could not succeed in achieving his goal.
- 3) That however on receipt of such information the witness no. 2 & 3 along with other neighboring people rushed to the place of occurrence and seeing them to come the accused person fled away and at the time of fleeing away the accused person snatched a sum of Rs. 450/- (Four Hundred Fifty Rupees) from your petitioner which he got as change after purchasing the groceries and depositing the price, more over the accused person also ransacked the groceries and out of which some of the items he took away.



- 4) That then the inmates of your petitioner took him to Pathardih B.P.H.C where the attending medical officer after giving him primary medical treatment referred him to Deben Mahato govt. Medical college & Hospital.
- 5) That pursuant to the advice of the attending medical officer x-ray was done where from it could be gather that unbearable pain with swelling at the back of his right knee was very much present for prolonged period since blood was clot in between his bone & muscle.
- 6) That your petitioner is still under treatment, but the complainant on 07.01.2022 after being fit to move had been to the Baghmundi P.S. with a written complainant depicting inter alia all the real scenario what happened wrongfully upon him when the officer on duty asked him come again later on if he would like to meet the O/C of the concerned P.S. with a prayer for setting the Law in motion, however he thereafter time and again had been to the said P.S. but neither he was allowed to meet the O/C nor the Police Personnel did accept his latter of complaint.
- 7) That your petitioner then sent his letter of complaint under registered cover with A/D addressing the O/C Baghmundi P.S. but then too no step was taken towards institution of any specific case so that the accused persons be prosecuted and punished.
- 8) That due to such inaction on the part of the police personnel of the concerned P.S. your petitioner informed the matter in writing to S.P Purulia on 22/02/2022, but unfortunately the District Police Administration still turned deaf ears to the same and no specific case has yet been instituted.
- 9) That search and seizure is very much warranted in the instant case and your petitioner is a very poor and rustic person heaving no such annual income for incurring expenses of a complaint case.





In light of the above it is therefore prayed that Your Honour may graciously be pleased to forward the instant petition of complaint to the Inspector in charge of Baghmundi P.S. with a direction upon him to investigate into the case treating the same as F.I.R under the provisions contemplated under sections 156 (3) Cr.P Code.
